AN ACT

- 1 Requiring the display of ratings on video movies.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Definitions.
- 5 The following words and phrases when used in this act shall
- 6 have the meanings given to them in this section unless the
- 7 context clearly indicates otherwise:
- 8 "Official rating." The official rating of a motion picture
- 9 by the Classification and Rating Administration of the Motion
- 10 Picture Association of America.
- 11 "Video movie." A video tape, video cassette or video disc,
- 12 and a prerecorded video display or visual depiction, a
- 13 prerecorded device that can be converted to a visual depiction
- 14 or any other reproduction or reconstruction of a motion picture.
- 15 Section 2. Display of official rating on video movies.

- 1 No person shall sell, rent, loan or otherwise disseminate or
- 2 distribute, for monetary consideration, a video movie, unless
- 3 the official rating of the motion picture from which the video
- 4 movie is copied is clearly and prominently displayed in boldface
- 5 type on the outside of the cassette, case, jacket or other
- 6 covering containing the video movie. The video movie shall be
- 7 clearly and prominently marked as "Not Rated" or "NR" if:
- 8 (1) the motion picture from which the video movie is
- 9 copied has no official rating;
- 10 (2) the official rating of the motion picture from which
- 11 the video movie is copied is not readily available to such
- 12 persons; or
- 13 (3) the video movie has been altered so that its content
- materially differs from the motion picture.
- 15 Section 3. Designation of department or agency for inspection.
- 16 Any county, by resolution of its legislative body, or any
- 17 other municipality by ordinance of its governing body, is hereby
- 18 authorized to designate a department or agency of such county or
- 19 municipality, respectively, to inspect video cassettes prior to
- 20 distribution to insure compliance with the provisions of this
- 21 act.
- 22 Section 4. Fund for enforcement.
- 23 The designated department or agency in section 3 shall
- 24 establish a fund in which the fines collected under this act
- 25 shall be deposited for the exclusive purpose of carrying out the
- 26 enforcement of this act.
- 27 Section 5. Penalty.
- Any person who violates section 2 commits a summary offense
- 29 and shall, upon conviction, be sentenced to pay a fine of not
- 30 more than \$500 for each violation.

- 1 Section 6. Effective date.
- 2 This act shall take effect in 120 days.
