AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, requiring lessors of vehicles to reveal the names
- 3 of lessees in certain cases.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 75 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 1305.1. Identity of lessees.
- 9 (a) Duty of lessor.--If the owner of a vehicle leases the
- 10 vehicle to another person and the vehicle remains registered in
- 11 the name of the lessor, the lessor shall, upon request, reveal
- 12 the identity of the lessee of the vehicle to any law enforcement
- 13 officer of the Commonwealth, or a political subdivision thereof,
- 14 who has reasonable grounds to believe the vehicle was involved
- 15 <u>in an accident or violation of law, including a parking</u>
- 16 violation.
- 17 (b) Penalty.--A person who violates this section commits a

- 1 summary offense and shall, upon conviction, be sentenced to pay
- 2 <u>a fine of not less than \$100 nor more than \$500.</u>
- 3 Section 2. Section 6148 of Title 75 is amended to read:
- 4 § 6148. Applicability to leased vehicles.
- 5 An agreement or arrangement entered into, or a declaration
- 6 issued, under the authority of this subchapter may contain
- 7 provisions under which a leased vehicle properly registered by
- 8 the lessor may be entitled, subject to terms and conditions
- 9 stated therein, to the exemptions, benefits and privileges
- 10 extended by such agreement, arrangement or declaration[.],
- 11 provided that the lessor agrees to reveal the identity of the
- 12 <u>lessee of the vehicle to any law enforcement officer of the</u>
- 13 Commonwealth, or a political subdivision thereof, who has
- 14 reasonable grounds to believe the vehicle was involved in an
- 15 <u>accident or violation of law, including a parking violation.</u>
- 16 Section 3. This act shall take effect in 60 days.
