## AN ACT

Amending the act of May 26, 1947 (P.L.318, No.140), entitled, as amended, "An act relating to the public practice of certified 3 public accountants; providing for the certification of persons desiring to practice, the registrations of public 5 accountants, requiring continuing education for registrants, and for the suspension and revocation of such certificates, 7 subject to appeal and for their reinstatement; prescribing 8 the powers and duties of the State Board of Accountancy and 9 the Department of State; providing for ownership of working papers; defining unlawful acts and acts not unlawful; 10 11 providing penalties, and repealing existing laws," further 12 providing for a title or designation. 13 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 14 15 Section 1. Sections 8.7(4) and 12(1) of the act of May 26, 1947 (P.L.318, No.140), known as The C.P.A. Law, amended March 16 7, 1984 (P.L.106, No.23), are amended to read: 17 18 Section 8.7. Registration of Public Accountants. -- Any person 19 (i) who is a resident of this Commonwealth or has a place of 20 business therein, and (ii) who has attained the age of eighteen 21 years, and (iii) who is of good moral character, and (iv) meets the requirements of clause (1) or (2) to the satisfaction of the 22

- 3 in the Pennsylvania Bulletin of the announcement that

- 6 (4) The board shall in each case determine whether the
- 7 applicant qualified for registration. Any individual who is so
- 8 registered and who holds a permit issued under section 8.2 of
- 9 this act shall be styled and known as a "public accountant[.]"

- 12 Section 12. Unlawful Acts.--\* \* \*
- 13 (1) It is unlawful for any person, partnership or
- 14 corporation to assume or use the title or designation "certified
- 15 accountant, " "chartered accountant, " "enrolled accountant, "
- 16 "licensed accountant," "registered accountant," ["licensed
- 17 public accountant,"] "registered public accountant," or
- 18 "accredited accountant," or any other title or designation
- 19 likely to be confused with "certified public accountant" or
- 20 "public accountant," or any of the abbreviations "CA," "EA,"
- 21 "RA," "LA," "RPA," ["LPA,"] or "AA," or similar abbreviations
- 22 likely to be confused with "CPA": Provided, however, That anyone
- 23 who is a current licensee may hold himself out to the public as
- 24 an "accountant," "licensed public accountant," "auditor" or
- 25 "accountant and auditor"[.] and may use the designation "LPA."
- 26 Any provision of this act referring to "public accountant" shall
- 27 apply to a "licensed public accountant."

- 29 Section 2. This act shall take effect immediately.
