AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Department of Transportation and the
- 3 Governor, to sell and convey a tract of land situate in
- 4 Fairview Township, York County, Pennsylvania.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The Department of General Services, with the
- 8 approval of the Department of Transportation and the Governor,
- 9 is authorized and directed on behalf of the Commonwealth of
- 10 Pennsylvania to sell and convey to the Patrick W. Milano
- 11 Detachment, Marine Corps League, for a consideration of \$15,000,
- 12 the following described tract of land situate in Fairview
- 13 Township, York County, Pennsylvania, bounded and described as
- 14 follows:
- 15 Beginning at a point, said point being the southeast corner
- 16 of Ross Avenue and First Street, thence by the southern right-
- 17 of-way line of Ross Avenue, south 75 degrees 58 minutes 00
- 18 seconds east a distance of 200.00 feet to a point at lands of

- 1 Pennsylvania Department of Transportation, Airport. Thence by
- 2 the same, generally following the toe of slope, the following
- 3 three courses and distances:
- 4 (1) South 50 degrees 48 minutes 50 seconds west a
- 5 distance of 95.45 feet to a point.
- 6 (2) South 36 degrees 17 minutes 51 seconds west a
- 7 distance of 96.02 feet to a point.
- 8 (3) South 57 degrees 35 minutes 02 seconds west a
- 9 distance of 91.77 feet to a point.
- 10 Thence by the same, north 58 degrees 14 minutes 21 seconds west
- 11 a distance of 45.40 feet to a point on the eastern right-of-way
- 12 line of First Street. Thence by the same, north 14 degrees 02
- 13 minutes 00 seconds east a distance of 218 feet to a point, the
- 14 place of beginning.
- 15 Containing 28,862.495 square feet.
- 16 Section 2. The conveyance shall be made under and subject to
- 17 all easements, servitudes and rights of others, including, but
- 18 not confined to, streets, roadways and rights of any telephone,
- 19 telegraph, water, electric, sewer, gas or pipeline companies, as
- 20 well as under and subject to any interest, estates or tenancies
- 21 vested in third persons, whether or not appearing of record, for
- 22 any portion of the land or improvements erected thereon.
- 23 Section 3. The deed of conveyance shall be approved as
- 24 provided by law and shall be executed by the Secretary of
- 25 General Services in the name of the Commonwealth of
- 26 Pennsylvania.
- 27 Section 4. Costs and fees incidental to this conveyance
- 28 shall be borne by the grantee.
- 29 Section 5. All money received from the sale of the land
- 30 shall be deposited in the Motor License Fund.

1 Section 6. This act shall take effect immediately.
