AN ACT

1 Amending the act of April 9, 1929 (P.L.177, No.175), entitled
2 "An act providing for and reorganizing the conduct of the
3 executive and administrative work of the Commonwealth by the
4 Executive Department thereof and the administrative
5 departments, boards, commissions, and officers thereof,
6 including the boards of trustees of State Normal Schools, or
7 Teachers Colleges; abolishing, creating, reorganizing or
8 authorizing the reorganization of certain administrative
9 departments, boards, and commissions; defining the powers and
10 duties of the Governor and other executive and administrative
11 officers, and of the several administrative departments,
12 boards, commissions, and officers; fixing the salaries of the
13 Governor, Lieutenant Governor, and certain other executive
14 and administrative officers; providing for the appointment of
15 certain administrative officers, and of all deputies and
16 other assistants and employees in certain departments, boards,
17 and commissions; and prescribing the manner in which the
18 number and compensation of the deputies and all other
19 assistants and employees of certain departments, boards and
20 commissions shall be determined," AUTHORIZING THE COMPTROLLER <—
21 OF THE HOUSE OF REPRESENTATIVES TO MAKE CERTAIN LAPSES;
22 FURTHER PROVIDING FOR FEES COLLECTED BY ADMINISTRATIVE

26 and other devices at the time a road is repaired or

28 ~~authority,~~ MUNICIPALITY OR AUTHORITY owner; AND FURTHER <—

1 PROVIDING FOR THE POWERS OF THE DEPARTMENT OF GENERAL
2 SERVICES AND THE DEPARTMENT OF REVENUE; TRANSFERRING THE <—
3 PENNSYLVANIA CONSERVATION CORPS FROM THE DEPARTMENT OF
4 ENVIRONMENTAL RESOURCES TO THE DEPARTMENT OF LABOR AND
5 INDUSTRY AND CONTINUING ITS EXISTENCE; AND MAKING REPEALS.
