AN ACT

- 1 Providing for cost-of-living increases in the amount of
- 2 compensation payable to a recipient of workmen's
- 3 compensation; creating a Workmen's Compensation COLA Fund;
- 4 further providing for the powers and duties of the Department
- of Labor and Industry; and making an appropriation.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Workmen's
- 10 Compensation COLA Fund Act.
- 11 Section 2. Annual cost-of-living adjustment.
- 12 The amount of workmen's compensation payable to a recipient
- 13 under the act of June 2, 1915 (P.L.736, No.338), known as The
- 14 Pennsylvania Workmen's Compensation Act, shall be increased on
- 15 July 1 annually.
- 16 Section 3. Rate of adjustment.
- 17 The rate of adjustment shall be identical to the percentage
- 18 increase in the cost of living for the immediately preceding,

- 1 completed calendar year, as published by the United States
- 2 Department of Labor.
- 3 Section 4. Duty of Department of Labor and Industry.
- 4 Each cost-of-living adjustment, or COLA, to the amount of
- 5 workmen's compensation payable to a recipient under the act of
- 6 June 2, 1915 (P.L.736, No.338), known as The Pennsylvania
- 7 Workmen's Compensation Act, shall be paid out of the Workmen's
- 8 Compensation COLA Fund, and the Department of Labor and Industry
- 9 shall administer the program and shall insure that timely
- 10 payments are made. The department shall determine annually the
- 11 amount necessary to fund the adjustment.
- 12 Section 5. Fund created.
- 13 The Workmen's Compensation COLA Fund is created in the
- 14 Department of Labor and Industry, to be funded as follows:
- 15 (1) An initial appropriation, under section 8, of the
- 16 General Assembly.
- 17 (2) Contributions from workers, as the term is defined
- 18 under the act of June 2, 1915 (P.L.736, No.338), known as The
- 19 Pennsylvania Workmen's Compensation Act.
- 20 (3) Contributions from each employer in this
- 21 Commonwealth.
- 22 Section 6. Workers' contributions.
- 23 The Department of Labor and Industry shall determine
- 24 annually, based on its determination under section 4 of the
- 25 amount necessary to fund the adjustment, the amount which shall
- 26 be deducted from the gross income of workers in this
- 27 Commonwealth, as the term "worker" is defined in the act of June
- 28 2, 1915 (P.L.736, No.338), known as The Pennsylvania Workmen's
- 29 Compensation Act.
- 30 Section 7. Employers' contributions.

- 1 The Department of Labor and Industry shall determine
- 2 annually, based on its determination under section 3 of the
- 3 amount necessary to fund the adjustment, the amount which shall
- 4 be deducted from the gross profit of employers in this
- 5 Commonwealth.
- 6 Section 8. Appropriation.
- 7 The sum of \$1,000,000, or as much thereof as may be
- 8 necessary, is appropriated to the Department of Labor and
- 9 Industry to provide the initial contribution to carry out the
- 10 provisions of this act in its first year of effect.
- 11 Section 9. Effective date.
- 12 This act shall take effect in 60 days.
