AN ACT

- 1 Amending Title 30 (Fish) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the commission to fix license
- 3 and permit fees.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 2102 of Title 30 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subsection to read:
- 8 § 2102. Rules and regulations.
- 9 * * *
- 10 (e) License and permit fees.--Notwithstanding any provisions
- 11 of Chapters 27 (relating to fishing licenses), 29 (relating to
- 12 special licenses and permits), 31 (relating to regulated fishing
- 13 lakes), 33 (relating to propagation and sale of fish) and 35
- 14 (relating to dams, bar racks and migration devices) to the
- 15 contrary, for the license or permit year beginning on or after
- 16 January 1, 1991, and each year thereafter, the commission shall
- 17 have the power and may, by regulation, annually fix the fees to
- 18 be assessed and collected for all licenses and permits.

- 1 Section 2. Section 5104 of Title 30 is amended to read:
- 2 § 5104. Fees.
- 3 <u>(a) General rule.--</u>The following fees apply to
- 4 registrations, licenses, permits and capacity plates issued
- 5 under this part and the fees collected shall be deposited in the
- 6 State Treasury in the Boat Fund:
- 7 (1) Owner registration (boats less than 16 feet in
- 8 length), \$4 per year.
- 9 (2) Owner registration (boats 16 feet or longer), \$6 per
- 10 year.
- 11 (3) Duplicate owner registration, \$1 each.
- 12 (4) Dealer registration, \$15 per year.
- 13 (5) Additional dealer registration, \$5 each.
- 14 (6) License for operator of passenger-carrying boat, \$5
- each.
- 16 (7) Capacity plate, \$2 each.
- 17 (8) Permit for special marine event, \$2 each.
- 18 (b) Established by commission. -- For the registration or
- 19 license year beginning on or after January 1, 1991, and each
- 20 year thereafter, the commission shall have the power and may, by
- 21 regulation, annually fix the amount of the fees to be collected
- 22 under subsection (a).
- 23 Section 3. This act shall take effect in 60 days.
