AN ACT

1 Amending Title 34 (Game) of the Pennsylvania Consolidated 2 Statutes, further providing for killing game or wildlife to 3 protect property. The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby enacts as follows: 6 Section 1. Section 2121(a) and (c) of Title 34 of the Pennsylvania Consolidated Statutes are amended to read: 8 Killing game or wildlife to protect property. 9 General rule. -- Subject to any limitations in this 10 subchapter, nothing in this title shall be construed to prohibit any person from killing any game or wildlife: 11 12 which the person may witness actually engaged in the 13 material destruction of cultivated crops, fruit trees, 14 vegetables, livestock, poultry, fish hatcheries or beehives;

anywhere on the property under the person's control,

including detached lands being [cultivated] used for the same

or similar purposes, immediately following such destruction;

- 1 (3) where the presence of the game or wildlife on any
- 2 cultivated lands, fish hatcheries or fruit orchards is just
- 3 cause for reasonable apprehension of additional imminent
- 4 destruction.
- 5 Lands divided by a public highway shall not be construed as
- 6 detached lands. Any person who wounds any game or wildlife shall
- 7 immediately make a reasonable effort to find and kill the game
- 8 or wildlife. Every person shall comply with all other
- 9 regulations in this subchapter pertaining to the method and
- 10 manner of killing, reporting the killing and the disposition of
- 11 game or wildlife and their skins and carcasses.

- 13 (c) Definition.--As used in this subchapter, the word
- 14 "person" shall be limited to any person cultivating, as a
- 15 primary means of gaining a livelihood, any lands for general or
- 16 specialized crop purposes, truck farming or fruit orchard or
- 17 nursery being regularly maintained or operating a fish hatchery,
- 18 as either the owner, lessee or a member of the family of the
- 19 owner or lessee assisting with the cultivation of the land or
- 20 operation of the fish hatchery, or a domiciled member of the
- 21 household of the owner or lessee or an employee of the owner or
- 22 lessee, regularly and continuously assisting in the cultivation
- 23 of the land or operation of the fish hatchery.
- 24 Section 2. This act shall take effect in 60 days.
