AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for the sale of
- 3 firearms; providing for the transfer of firearms; and
- 4 providing for the registration of firearms.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6111 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 6111. Sale or transfer of firearms.
- 10 (a) Time and manner of delivery. -- No seller or transferor,
- 11 including an individual who is not a dealer, shall deliver a
- 12 firearm to the purchaser or transferee thereof until 48 hours
- 13 shall have elapsed from the time of the application for the
- 14 purchase thereof, and when delivered, said firearm shall be
- 15 securely wrapped and shall be unloaded.
- 16 (b) Statement to be signed by purchaser. -- At the time of
- 17 applying for the purchase of a firearm, the purchaser shall sign
- 18 in quadruplicate and deliver to the seller a statement

- 1 containing his full name, address, occupation, color, place of
- 2 birth, the date and hour of application, the caliber, length of
- 3 barrel, make, model, and manufacturer's number of the firearm to
- 4 be purchased, and a statement that he has never been convicted
- 5 in this Commonwealth, or elsewhere, of a crime of violence. The
- 6 seller shall, within six hours after such application, sign and
- 7 attach his address and forward by registered or certified mail
- 8 one copy of such statement to the chief or head of the police
- 9 force or police department of the city, or the sheriff of the
- 10 county of the place of business of the seller, the duplicate,
- 11 duly signed by the seller, shall, within seven days, be sent by
- 12 him, with his address, to the Commissioner of the Pennsylvania
- 13 State Police, the triplicate he shall retain for six years, and
- 14 the quadruplicate with the proper signature and address of the
- 15 seller shall, within six hours after such application, be
- 16 forwarded by registered or certified mail to the chief or head
- 17 of the police force or police department of the city or to the
- 18 sheriff of the county of which the buyer is a resident.
- 19 (c) [Exemption] Application.--
- 20 $\underline{(1)}$ This section shall not apply to sales at wholesale.
- 21 (2) This section shall apply to sales and transfers to
- or from persons within this Commonwealth to or from persons
- outside this Commonwealth.
- 24 (d) Forms. -- Application forms shall be made available at all
- 25 <u>firearms dealers and hunting and fishing license agents.</u>
- 26 Section 2. Section 6119 of Title 18 is amended to read:
- 27 § 6119. Violation penalty.
- 28 An offense under this [section] subchapter constitutes a
- 29 misdemeanor of the first degree.
- 30 Section 3. Title 18 is amended by adding a section to read:

- 1 § 6124. Registration of firearms.
- 2 Any person having a firearm which is not registered under
- 3 <u>section 6111 (relating to sale or transfer of firearms) shall</u>
- 4 register it with the Pennsylvania State Police within 180 days
- 5 of the effective date of this section.
- 6 Section 4. The heading of section 6124 of Title 18, added
- 7 December 19, 1988 (P.L.1275, No.158), is amended to read:
- 8 § [6124] 6125. Administrative regulations.
- 9 * * *
- 10 Section 5. Information regarding the provisions of this act
- 11 shall be provided by the Pennsylvania State Police to all
- 12 sheriffs and municipal police agencies.
- 13 Section 6. This act shall take effect in 60 days.
