A RESOLUTION

- 1 Memorializing Congress to pass legislation to increase the
 2 number of Soviet Jewish refugees permitted to emigrate to the
 3 United States, and to encourage the restoration of the United
- 4 States policy which granted automatic refugee status to
- 5 Soviet Jews.
- 6 WHEREAS, There are two million Jews in the Soviet Union; and
- 7 WHEREAS, These Soviet citizens have been the subject of
- 8 discrimination in employment and have been denied the freedom to
- 9 practice their religion; and
- 10 WHEREAS, Four hundred thousand of these Jews have risked the
- 11 stigma of social isolation by applying to emigrate; and
- 12 WHEREAS, The number of Soviet Jews permitted to emigrate in
- 13 1988 was almost 19,000, more than twice the number permitted in
- 14 1987 and the highest total in nine years; and
- 15 WHEREAS, The number which may be permitted to emigrate in
- 16 1989 may be as many as 40,000; and
- 17 WHEREAS, Many of these emigrants wish to settle in the United

- 1 States; and
- 2 WHEREAS, The United States government has set aside only
- 3 12,500 slots for Soviet Jewish refugees for the 1989 fiscal
- 4 year, and virtually all of these slots have been allocated; and
- 5 WHEREAS, An estimated 19,000 additional refugee slots for
- 6 Soviet Jews this year are required to accommodate the needs of
- 7 Soviet Jewish refugees; and
- 8 WHEREAS, There are approximately 7,000 Soviet Jews who have
- 9 successfully emigrated and who are languishing in refugee
- 10 centers in Italy and Austria awaiting entry into the United
- 11 States; and
- 12 WHEREAS, Until a change in United States policy in September
- 13 1988, Soviet Jews were automatically granted refugee status and
- 14 were thus eligible for travel, resettlement and medical
- 15 benefits; and
- 16 WHEREAS, Starting in September, the United States government
- 17 has revoked this policy and has considered granting refugee
- 18 status on a case-by-case basis, resulting in the denial of
- 19 refugee status to more than a third of Soviet Jewish emigrants;
- 20 and
- 21 WHEREAS, Those denied refugee status are offered parole
- 22 status, which permits the right to work but denies eligibility
- 23 for changing their status to that of a "permanent resident"
- 24 which is a precursor for "citizenship" status; and
- WHEREAS, The Emergency Refugee Act of 1989 (H.R. 1605),
- 26 introduced on March 22, 1989, by Rep. Howard Berman (D-
- 27 California), would authorize the admission of up to 19,000 more
- 28 Soviet Jewish refugees and finance the cost of this policy by
- 29 borrowing \$100 million from the State Legalization Impact
- 30 Assistance Grant (SLIAG) program; and

- 1 WHEREAS, H.R. 1605 would also increase the number of refugees
- 2 admitted from other refugee communities; and
- 3 WHEREAS, H.R. 1605 has been endorsed by groups such as the
- 4 United Farm Workers, the National Council for La Raza and the
- 5 Council of Jewish Federations; therefore be it
- 6 RESOLVED, That the House of Representatives of the
- 7 Commonwealth of Pennsylvania support human rights and the rights
- 8 of Soviet Jewry to emigrate to the United States, and that the
- 9 policy of the United States be changed to facilitate the
- 10 emigration of Soviet Jews and other persecuted minorities around
- 11 the world; and be it further
- 12 RESOLVED, That the House of Representatives of the
- 13 Commonwealth of Pennsylvania memorialize its desire that the
- 14 Congress of the United States will expeditiously enact H.R. 1605
- 15 to increase the number of refugees permitted to enter the United
- 16 States; and be it further
- 17 RESOLVED, That the Attorney General of the United States be
- 18 encouraged to restore the policy of granting automatic refugee
- 19 status to emigrating Soviet Jews.
