AN ACT

- 1 Amending the act of May 1, 1933 (P.L.103, No.69), entitled "An
- act concerning townships of the second class; and amending,
- 3 revising, consolidating, and changing the law relating
- 4 thereto, "further regulating contracts, advertisements,
- 5 specifications and bids for certain contracts.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 802(a) and (e) of the act of May 1, 1933
- 9 (P.L.103, No.69), known as The Second Class Township Code,
- 10 reenacted and amended July 10, 1947 (P.L.1481, No.567) and
- 11 amended December 22, 1981 (P.L.539, No.156) and December 17,
- 12 1986 (P.L.1686, No.198), are amended AND THE SECTION IS AMENDED
- 13 BY ADDING SUBSECTIONS to read:
- 14 Section 802. Letting Contracts.--(a) Each township shall
- 15 have the power to make, to authorize, and to ratify,
- 16 expenditures for lawful purposes from funds available therefor,
- 17 by borrowing within legal limitations: Provided, That all
- 18 contracts or purchases in excess of [four thousand dollars] ten

- 1 thousand dollars THE MONETARY THRESHOLD LEVEL FOR THE TOWNSHIP,
- 2 except those hereinafter mentioned, shall not be made except
- 3 with and from the lowest responsible bidder, after due notice in
- 4 one newspaper of general circulation, published or circulating
- 5 in the county in which the township is situated, at least two
- 6 times, at intervals of not less than three days where daily
- 7 newspapers of general circulation are employed for such
- 8 publication, or in case weekly newspapers are employed, then the
- 9 notice shall be published once a week for two successive weeks.
- 10 The first advertisement shall be published not more than forty-
- 11 five days and the second advertisement not less than ten days
- 12 prior to the date fixed for the opening of bids. Notice of
- 13 proposed contracts or purchases shall also be posted where the
- 14 board of supervisors normally meets or in a conspicuous place
- 15 within the township.
- 16 (A.1) THE MONETARY THRESHOLD LEVEL ABOVE WHICH COMPETITIVE
- 17 BIDDING SHALL BE REQUIRED SHALL BE ONE PER CENTUM (1%) OF THE
- 18 TOTAL OF ALL BUDGETS ADMINISTERED BY THE TOWNSHIP, BUT IN NO
- 19 CASE SHALL THE MONETARY THRESHOLD BE LESS THAN FOUR THOUSAND
- 20 DOLLARS, NOR MORE THAN TEN THOUSAND DOLLARS.
- 21 (A.2) WRITTEN OR TELEPHONIC PRICE QUOTATIONS FROM AT LEAST
- 22 THREE QUALIFIED AND RESPONSIBLE CONTRACTORS SHALL BE REQUESTED
- 23 FOR ALL CONTRACTS THAT EXCEED FOUR THOUSAND DOLLARS BUT ARE LESS
- 24 THAN THE AMOUNT REQUIRING ADVERTISEMENT AND COMPETITIVE BIDDING
- 25 OR, IN LIEU OF PRICE QUOTATIONS, A MEMORANDUM SHALL BE KEPT ON
- 26 FILE SHOWING THAT FEWER THAN THREE QUALIFIED CONTRACTORS EXIST
- 27 IN THE MARKET AREA WITHIN WHICH IT IS PRACTICABLE TO OBTAIN
- 28 QUOTATIONS. A WRITTEN RECORD OF TELEPHONIC PRICE QUOTATIONS
- 29 SHALL BE MADE AND SHALL CONTAIN AT LEAST THE DATE OF THE
- 30 QUOTATION, THE NAME OF THE CONTRACTOR AND THE CONTRACTOR'S

- 1 REPRESENTATIVE, THE CONSTRUCTION, RECONSTRUCTION, REPAIR,
- 2 MAINTENANCE OR WORK WHICH WAS THE SUBJECT OF THE QUOTATION AND
- 3 THE PRICE. WRITTEN PRICE QUOTATIONS, WRITTEN RECORDS OF
- 4 TELEPHONIC PRICE QUOTATIONS AND MEMORANDA SHALL BE RETAINED FOR
- 5 A PERIOD OF THREE YEARS.
- 6 * * *
- 7 (e) The contracts or purchases made by any supervisors
- 8 involving an expenditure of over [four thousand dollars] <u>ten</u>
- 9 thousand dollars THE MONETARY THRESHOLD LEVEL FOR THE TOWNSHIP, <
- 10 which shall not require advertising or bidding as hereinbefore
- 11 provided, are as follows:
- 12 (1) Those made for maintenance, repairs or replacements for
- 13 water, electric light and other public works of the township,
- 14 provided they do not constitute new additions, extensions or
- 15 enlargements of existing facilities and equipment, but a bond
- 16 may be required by the supervisors as in other cases of work
- 17 done.
- 18 (2) Those made for improvements, repairs or maintenance of
- 19 any kind, made or provided by any township, through its own
- 20 employes: Provided, however, That all materials used for road
- 21 improvement, maintenance and/or construction in excess of [four
- 22 thousand dollars] ten thousand dollars THE MONETARY THRESHOLD
- 23 <u>LEVEL FOR THE TOWNSHIP</u> be subject to the advertising
- 24 requirements contained herein.
- 25 (3) Those where particular types, models or pieces of new
- 26 equipment, articles, apparatus, appliances, vehicles, or parts
- 27 thereof, are desired by the supervisors, which are patented and
- 28 manufactured products.
- 29 (4) Those involving any policies of insurance or surety
- 30 company bonds, those made for public utility service under

- 1 tariffs on file with the Pennsylvania Public Utility Commission,
- 2 those made with another political subdivision, county, the
- 3 Commonwealth of Pennsylvania or the Federal Government, or any
- 4 agency of the Commonwealth or Federal Government, or any
- 5 municipal authority, including the sale, leasing or loan of any
- 6 supplies or materials by the Commonwealth, or the Federal
- 7 Government, or their agencies, but the price thereof, or the
- 8 expenditure therefor, shall not be in excess of those fixed by
- 9 the Commonwealth, the Federal Government or their agencies.
- 10 (5) Those involving personal or professional services.
- 11 * * *
- 12 Section 2. Sections 802.1 and 804 of the act, amended
- 13 December 22, 1981 (P.L.539, No.156), are amended to read:
- 14 Section 802.1. Evasion of Advertising Requirements.--No
- 15 supervisor or supervisors shall evade the provisions of section
- 16 eight hundred two as to advertising for bids, by purchasing or
- 17 contracting for services and personal properties piecemeal for
- 18 the purpose of obtaining prices under [four thousand dollars]
- 19 upon ten thousand dollars UPON] THE MONETARY THRESHOLD LEVEL FOR

- 20 THE TOWNSHIP transactions which should, in the exercise of
- 21 reasonable discretion and prudence, be conducted as one
- 22 transaction amounting to more than [four thousand dollars] ten
- 23 thousand dollars THE MONETARY THRESHOLD LEVEL FOR THE TOWNSHIP.
- 24 This provision is intended to make unlawful the evading of
- 25 advertising requirements by making a series of purchases or
- 26 contracts each for less than the advertising requirement price,
- 27 or by making several simultaneous purchases or contracts, each
- 28 below said price, when, in either case, the transactions
- 29 involved should have been made as one transaction for one price.
- 30 Any supervisors who so vote in violation of this provision, and

- 1 who know that the transaction upon which they so vote is or
- 2 ought to be part of a larger transaction and that it is being
- 3 divided in order to evade the requirements as to advertising for
- 4 bids, shall be jointly and severally subject to surcharge for
- 5 ten per centum of the full amount of the contract or purchase.
- 6 Whenever it shall appear that a supervisor may have voted in
- 7 violation of this section, but the purchase or contract on which
- 8 he so voted was not approved by the board of supervisors, this
- 9 section shall be inapplicable.
- 10 Section 804. Separate Specifications for Branches of Work.--
- 11 In the preparation of specifications for the erection or
- 12 alteration of any public building, when the entire cost of such
- 13 work exceeds [four thousand dollars] ten thousand dollars THE
- 14 MONETARY THRESHOLD LEVEL FOR THE TOWNSHIP, the architect,
- 15 engineer, or person preparing such specifications shall prepare
- 16 separate specifications for the plumbing, heating, ventilating,
- 17 and electrical work, and the township shall receive separate
- 18 bids upon each of such branches of work and award the contract
- 19 for the same to the lowest responsible bidder.
- 20 Section 3. This act shall take effect in 60 days.
