AN ACT

1 Designating the Birmingham Bridge in Pittsburgh, Allegheny
2 County, as the James A. Romanelli Bridge; DESIGNATING THE <—
3 TENTH STREET BRIDGE IN PITTSBURGH, ALLEGHENY COUNTY, AS THE
4 STEVE SEVENTY MEMORIAL BRIDGE; DESIGNATING A PORTION OF <—
5 INTERSTATE HIGHWAY 279 IN THE CITY OF PITTSBURGH AS THE
6 EUGENE F. SCANLON EXPRESSWAY AND A PORTION OF INTERSTATE <—
7 HIGHWAY 279 IN THE CITY OF PITTSBURGH AS THE EAST STREET
8 VALLEY EXPRESSWAY; DESIGNATING A BRIDGE IN AMBRIDGE BOROUGH,
9 BEAVER COUNTY, AS THE CHARLES P. LAUGHLIN MEMORIAL BRIDGE;
10 DESIGNATING THE BRIDGE BETWEEN CHARLEROI AND MONESSEN ON <—
11 STATE ROUTE 2018 IN WASHINGTON AND WESTMORELAND COUNTIES AS
12 THE C. VANCE DEICAS MEMORIAL BRIDGE; DESIGNATING THE SECTION
13 OF L.R.238, SPUR C, IN MERCER COUNTY, PENNSYLVANIA, AS THE
14 NICK STRIMBU JUNIOR INDUSTRIAL CORRIDOR; and making a repeal.

15 The General Assembly of the Commonwealth of Pennsylvania

16 hereby enacts as follows:

17 Section 1. The bridge known as the Birmingham Bridge in
18 Pittsburgh, Allegheny County, formerly known as the Brady Street
19 Bridge, is hereby designated and shall be known as the James A.
20 Romanelli Bridge.

21 SECTION 2. THE BRIDGE KNOWN AS THE TENTH STREET BRIDGE IN <—
22 PITTSBURGH, ALLEGHENY COUNTY, IS HEREBY DESIGNATED AND SHALL BE

1 KNOWN AS THE STEVE SEVENTY MEMORIAL BRIDGE.

2 SECTION ~~2~~ 3. THE BRIDGE FROM STATE ROUTE 65 OVER CONRAIL IN <—
3 AMBRIDGE BOROUGH, BEAVER COUNTY, NEAR THE AMERICAN BRIDGE WORKS
4 INDUSTRIAL PARK IS HEREBY DESIGNATED AND SHALL BE KNOWN AS THE
5 CHARLES P. LAUGHLIN MEMORIAL BRIDGE.

6 SECTION 4. THE BRIDGE BETWEEN CHARLEROI AND MONESSEN ON <—
7 STATE ROUTE 2018 IN WASHINGTON AND WESTMORELAND COUNTIES SHALL
8 BE KNOWN AS THE C. VANCE DEICAS MEMORIAL BRIDGE.

9 Section ~~2-3-4~~ 5. The Department of Transportation shall <—
10 erect appropriate signs or markers to evidence the ~~name of the~~ <—
11 ~~bridge~~ NAMES OF THE BRIDGES. <—

12 SECTION ~~4-5~~ 6. THE PORTION OF INTERSTATE HIGHWAY 279, WITHIN <—
13 THE CITY OF PITTSBURGH, EXTENDING FROM PITTSBURGH'S BORDER WITH
14 ROSS TOWNSHIP TO THE ~~VETERANS MEMORIAL BRIDGE~~ VENTURE STREET <—
15 EXIT, IS DESIGNATED AND SHALL BE KNOWN AS THE EUGENE F. SCANLON
16 EXPRESSWAY. THE PORTION OF INTERSTATE HIGHWAY 279 WITHIN THE <—
17 CITY OF PITTSBURGH EXTENDING FROM THE VENTURE STREET EXIT TO THE
18 VETERANS MEMORIAL BRIDGE IS DESIGNATED AND SHALL BE KNOWN AS THE
19 EAST STREET VALLEY EXPRESSWAY. THE DEPARTMENT OF TRANSPORTATION
20 SHALL ERECT AND MAINTAIN APPROPRIATE SIGNS AND MARKERS TO
21 EVIDENCE THE NAME OF THE ~~EXPRESSWAY~~. EXPRESSWAYS. THE DEPARTMENT <—
22 SHALL ERECT A MONUMENT POSTED AT AN APPROPRIATE LOCATION ALONG
23 THE EAST STREET VALLEY EXPRESSWAY, RECOGNIZING THE CONTRIBUTION
24 OF 2,700 FAMILIES, WHOSE REMOVAL PERMITTED THE EXPRESSWAY'S
25 CONSTRUCTION.

26 SECTION 7. THAT SECTION OF L.R.238, SPUR C, IN MERCER <—
27 COUNTY, BETWEEN THE INTERCHANGE OF INTERSTATE 60 IN HERMITAGE
28 AND EAST STATE STREET IN SHARON, IS HEREBY DESIGNATED AND SHALL
29 BE KNOWN AS THE NICK STRIMBU JUNIOR INDUSTRIAL CORRIDOR. THE
30 DEPARTMENT OF TRANSPORTATION SHALL ERECT AND MAINTAIN ROAD

1 SIGNS, WHICH SHALL DISPLAY THE NAME OF NICK STRIMBU JUNIOR
2 INDUSTRIAL CORRIDOR, AT THE BEGINNING, MIDDLE AND THE END OF THE
3 SECTION OF HIGHWAY SO DESIGNATED.

4 Section ~~3-5-6~~ 8. The act of November 2, 1977 (P.L.220, <—
5 No.67), entitled "An act changing the name of the 'Brady Street
6 Bridge' in Pittsburgh, Allegheny County to the 'Birmingham
7 Bridge,'" is repealed.

8 ~~Section 4. This act shall take effect in 60 days.~~ <—

9 SECTION ~~6-7~~ 9. THIS ACT SHALL TAKE EFFECT IMMEDIATELY. <—
