10	XVI-B of the act of April 9, 1929 (P.L.343, No.176), known as
11	The Fiscal Code, shall apply to this act to the extent they are
12	not inconsistent with this act.
13	Section 2. Overall limitations on debt to be incurred for
14	capital projects.
15	The maximum principal amount of additional debt to be
16	incurred during the 1990-1991 fiscal year, and thereafter until

the enactment of the 1991-1992 capital budget specifying the maximum debt for the 1991-1992 fiscal year, for capital projects specifically itemized in a capital budget pursuant to section 7(a)(4) of Article VIII of the Constitution of Pennsylvania, and the fund to be charged with the repayment of such debt, shall, with respect to each category of capital projects, be as follows:
