## AN ACT

- 1 Requiring the superintendent of every public school district to
- 2 make available, upon request, lists of graduating seniors to
- 3 armed forces recruiters; and providing a penalty for the
- 4 misuse of any such lists.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Legislative intent.
- 8 It is the intent of the General Assembly through this
- 9 legislation to assist armed forces recruiters to achieve
- 10 additional access to potential recruits by compiling a list of
- 11 prospective graduating seniors for distribution, upon written
- 12 request, to armed forces recruiters for the cost thereof, for
- 13 recruiting purposes only.
- 14 Section 2. List of seniors to be compiled.

- 1 (a) Lists.--Subject to the limitations of subsection (b),
- 2 the superintendent of every public school district, except as
- 3 otherwise provided, shall make available to all armed forces
- 4 recruiters for the active component, reserve component and
- 5 National Guard component of the armed forces, the same access to
- 6 senior students as is available to institutions of higher
- 7 education and trade schools. Access shall include, but not be
- 8 limited to, a list of senior male and female students by name,
- 9 home address and, if published, telephone number, who at the end
- 10 of the respective academic year will graduate from the school
- 11 system. The list shall be compiled within 45 calendar days of
- 12 the effective date of this act and in succeeding years by the
- 13 first day of the academic year in which the senior students will
- 14 graduate.
- 15 (b) Notification. -- Each school district shall notify the
- 16 students, in writing, prior to the end of their junior year, of
- 17 the requirements imposed by subsection (a). Each student shall
- 18 be given at least 21 calendar days to request, in writing, to
- 19 the superintendent, exclusion of such student's name prior to
- 20 the release of such list.
- 21 Section 3. Optional compliance by nonpublic schools.
- 22 The governing body or board of each parochial, licensed
- 23 private and nonpublic school shall determine whether or not to
- 24 comply with the provisions of this act. If an affirmative
- 25 determination is made, then the principal of that parochial,
- 26 licensed private or nonpublic school shall comply with the
- 27 provisions of sections 2 and 4.
- 28 Section 4. Penalties.
- 29 A person who violates this act commits a summary offense and
- 30 shall, upon conviction, be sentenced to pay a fine of \$100. Each

- 1 day that a person violates this act shall constitute a separate
- 2 offense.
- 3 SECTION 5. REIMBURSEMENT OF COSTS.

- 4 ANY COSTS INCURRED BY PUBLIC AND NONPUBLIC SCHOOLS IN
- 5 COMPLYING WITH THIS ACT WILL BE REIMBURSED BY ARMED FORCES
- 6 RECRUITERS UPON WRITTEN DOCUMENTATION OF EXPENSES.
- 7 Section 5 6. Effective date.
