## AN ACT

Amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, further providing for THE POWERS AND DUTIES OF THE 3 PENNSYLVANIA GAME COMMISSION AND FOR senior resident license 4 qualifications; AUTHORIZING CERTAIN DISABLED PERSONS TO HUNT WITH CROSSBOWS; and deleting certain license requirements for regulated hunting grounds. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. - 17 (1) ANY DEVICE OTHER THAN A CENTERFIRE OR MUZZLE-LOADING

- 20 THAT ANY SEMIAUTOMATIC FIREARM MODIFIED TO PERMIT ONE
- 21 SHELL IN THE CHAMBER AND NO MORE THAN FOUR SHELLS IN A
- 22 MAGAZINE OR, SUBJECT TO SUBPARAGRAPH (II), A CROSSBOW MAY
- 23 BE USED BY A PERSON WHO SUFFERED AN AMPUTATION OR LOST

- 10 Unless otherwise provided, any person wishing to exercise any
- 11 of the privileges granted by this title shall first secure the
- 12 applicable resident or nonresident hunting or furtaker license
- 13 as follows:

- 15 (3) Senior resident hunting licenses or, at the option
- of the applicant, a senior lifetime resident hunting license
- 17 to residents who have reached or will reach their 65th
- birthday [prior to the date] <u>in the year</u> of the application
- 19 for the license. The commission shall develop, implement and
- 20 administer a system to provide tags, report cards and
- 21 applications to those residents who hold a senior lifetime
- resident hunting license issued under this paragraph. The
- 23 system shall require the applicant or license holder to pay
- any approved fee assessed by the issuing agent.

- 26 (6) Senior resident furtaker licenses or, at the option
- 27 of the applicant, a senior lifetime resident furtaker license
- to residents who have reached or will reach their 65th

- 6 (b) Regulated hunting grounds. -- A permit may be issued to
- 7 hunt on a regulated hunting ground to any person who presents a
- 8 doctor's certificate showing that the person is physically
- 9 unable to walk for an extended period of time, authorizing him
- 10 to hunt for, pursue and kill from an automobile or other vehicle
- 11 on regulated hunting grounds those species of game authorized
- 12 for release on such areas, subject to rules and regulations
