AN ACT

- 1 Amending the act of August 7, 1963 (P.L.549, No.290), entitled,
- as amended, "An act creating the Pennsylvania Higher
- 3 Education Assistance Agency; defining its powers and duties;
- 4 conferring powers and imposing duties on the Governor,
- 5 President Pro Tempore of the Senate, Speaker of the House of
- 6 Representatives, Superintendent of Public Instruction and the
- 7 Department of Auditor General; and making appropriations,"
- 8 authorizing loan forgiveness for certain teachers.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. The act of August 7, 1963 (P.L.549, No.290),
- 12 referred to as the Pennsylvania Higher Education Assistance
- 13 Agency Act, is amended by adding a section to read:
- 14 Section 4.4. Loan Forgiveness.--(a) Pursuant to subclause
- 15 (iii) of clause (1.1) of section 4, the board shall adopt a
- 16 policy of, and appropriate procedures for, granting forgiveness
- 17 for loan recipients who graduate from agency-approved
- 18 institutions in agency-approved programs, focusing on the

- 1 education of autistic children.
- 2 (b) For each calendar year that a person is employed as a
- 3 <u>certified teacher in classes emphasizing the education of</u>
- 4 <u>autistic children</u>, twenty-five per cent of the approved
- 5 indebtedness shall be forgiven. Payment shall be made in
- 6 accordance with the procedure established by the agency.
- 7 (c) The board of directors of the agency shall have the
- 8 power and its duty shall be to adopt rules and regulations
- 9 pursuant to the act of July 31, 1968 (P.L.769, No.240), referred
- 10 to as the Commonwealth Documents Law, and not inconsistent with
- 11 law governing matters relating to this section. The rules and
- 12 regulations shall include the manner of verification of
- 13 <u>employment</u>.
- 14 Section 2. This act shall apply to loan recipients who
- 15 graduate from agency-approved institutions in agency-approved
- 16 education programs on or after January 1, 1991.
- 17 Section 3. This act shall take effect immediately.
