AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- 2 act to consolidate, editorially revise, and codify the public 3 welfare laws of the Commonwealth," requiring the Department
- 4 of Public Welfare to provide and increase a State supplement
- 5 to the Federal Supplemental Security Income Program for
- 6 individuals requiring personal-care services who reside in
- 7 licensed personal-care homes; and making an appropriation.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 11 as the Public Welfare Code, is amended by adding a section to
- 12 read:
- 13 Section 434.2. State Supplement to Federal Supplemental
- 14 Security Income Program. -- (a) The department shall provide a
- 15 State supplement in the amount of one hundred fourteen dollars

- 1 and ninety cents (\$114.90) to the Federal Supplemental Security
- 2 <u>Income Program received by or for persons requiring personal</u>
- 3 care and residing in licensed personal-care facilities.
- 4 (b) The department shall increase, commencing with fiscal
- 5 year 1991-1992, the amount of the State supplement to the
- 6 Federal Supplemental Security Income Program being received by
- 7 or for persons residing in licensed personal-care homes over the
- 8 amount provided under the State program operating in fiscal year
- 9 1989-1990. Such increase shall be seven dollars (\$7) per day per
- 10 <u>resident recipient.</u>
- 11 Section 2. The sum of \$14,364,000, or as much thereof as may
- 12 be necessary, is hereby appropriated to the Department of Public
- 13 Welfare for the fiscal year July 1, 1991, to June 30, 1992, to
- 14 increase the State supplement by \$7 per day per resident
- 15 recipient.
- 16 Section 3. This act shall take effect July 1, 1991.
