AN ACT

Amending the act of June 11, 1968 (P.L.149, No.84), entitled "An act relating to volunteer firemen's relief associations, 2 3 clarifying their purposes and objectives, establishing criteria and standards for the conduct of their affairs, 5 providing for their formation, recognition, continuing 6 operation, and for their dissolution in appropriate 7 circumstances and the distribution of their funds, " further 8 providing for volunteer firemen's relief association funds. The General Assembly of the Commonwealth of Pennsylvania 9 10 hereby enacts as follows: 11 Section 1. Section 6(e)(2) of the act of June 11, 1968 12 (P.L.149, No.84), known as the Volunteer Firemen's Relief Association Act, is amended to read: 13 14 Section 6. * * * 15 The funds of any volunteer firemen's relief association 16 may be spent: * * * 17 (2) To purchase contracts of insurance which shall at the 18 least afford financial assistance to active members of the fire 19 20 service represented by the association against losses due to

- 1 injury suffered in the fire service and which may also provide
- 2 in the order named, (i) for payments to the widow or other
- 3 dependents of a member in the event of his death, (ii) for
- 4 protection of active firemen against disease, (iii) for the
- 5 replacement or purchase of prosthetic devices such as visual
- 6 aids, hearing aids, dentures, braces, crutches, and the like,
- 7 where such devices have been lost or damaged while the owner was
- 8 engaged in the fire service or where the need for such devices
- 9 arises because of functional impairment attributable to
- 10 participation in the fire service, (iv) for the repair or
- 11 replacement if necessary of articles of clothing damaged in the
- 12 course of participation in the fire service, [and] (v) for
- 13 <u>financial assistance to volunteer firemen who have actively</u>
- 14 participated in the fire service for twenty years and who have
- 15 <u>attained age sixty-five</u>, and (vi) for disability incurred after
- 16 service for a minimum of twenty years as a volunteer fireman.

- 18 Section 2. This act shall take effect in 60 days.
