AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, expanding the circumstances for
- 3 reporting suspected child abuse.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6311(a) of Title 23 of the Pennsylvania
- 7 Consolidated Statutes, added December 19, 1990 (P.L.
- 8 No.206), is amended to read:
- 9 § 6311. Persons required to report suspected child abuse.
- 10 (a) General rule.--Persons who, in the course of their
- 11 employment, occupation or practice of their profession, come
- 12 into contact with children shall report or cause a report to be
- 13 made in accordance with section 6313 (relating to reporting
- 14 procedure) when they have reason to believe, on the basis of
- 15 [their medical, professional or other training and experience,

- 1 that a child coming before them in their professional or
- 2 official capacity is an abused child.] information received in
- 3 the course of their employment, occupation or profession, that a
- 4 <u>child is an abused child. Persons are not required to report</u>
- 5 under this subsection if all of the following apply:
- 6 (1) The information is received through a communication
- 7 with someone other than the child.
- 8 (2) The communication is recognized by law or
- 9 <u>professional ethics as confidential.</u>
- 10 (3) The person concludes, in the exercise of sound
- 11 professional judgment, that the child is not in imminent
- 12 <u>danger of further abuse.</u>
- 13 The privileged communication between any professional person
- 14 required to report and the patient or client of that person
- 15 shall not apply to situations involving child abuse and shall
- 16 not constitute grounds for failure to report as required by this
- 17 chapter.
