AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further defining "child abuse."
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The definition of "child abuse" in section 6303
- 6 of Title 23 of the Pennsylvania Consolidated Statutes, added
- 7 December 19, 1990 (P.L.1240, No.206), is amended to read:
- 8 § 6303. Definitions.
- 9 The following words and phrases when used in this chapter
- 10 shall have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Child abuse." Serious physical or mental injury which is
- 13 not explained by the available medical history as being
- 14 accidental, sexual abuse, sexual exploitation or serious
- 15 physical neglect of a child under 18 years of age if the injury,
- 16 abuse or neglect has been caused by the acts or omissions of the

- 1 child's parents or by a person responsible for the child's
- 2 welfare, or any individual residing in the same home as the
- 3 child, or a paramour of the child's parent. The term also
- 4 <u>includes any act or failure to act or any series of acts or</u>
- 5 <u>failures to act by the child's parents or by a person</u>
- 6 responsible for the child's welfare, or any individual residing
- 7 <u>in the same home as the child, or a paramour of the child's</u>
- 8 parent that present or presented an imminent risk of serious
- 9 physical or mental injury to a child under 18 years of age. No
- 10 child shall be deemed to be physically or mentally abused for
- 11 the sole reason the child is in good faith being furnished
- 12 treatment by spiritual means through prayer alone in accordance
- 13 with the tenets and practices of a recognized church or
- 14 religious denomination by an accredited practitioner thereof or
- 15 is not provided specified medical treatment in the practice of
- 16 religious beliefs, or solely on the grounds of environmental
- 17 factors which are beyond the control of the person responsible
- 18 for the welfare of the child such as inadequate housing,
- 19 furnishings, income, clothing and medical care.

- 21 Section 2. This act shall take effect in 90 days.
