AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania 2 Consolidated Statutes, clarifying the circumstances in which
- 3 child protective services must obtain information on prior
- 4 reports of child abuse.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6313(b) of Title 23 of the Pennsylvania
- 8 Consolidated Statutes, added December 19, 1990 (P.L.1240,
- 9 No.206), is amended to read:
- 10 § 6313. Reporting procedure.
- 11 * * *
- 12 (b) Oral reports.--Oral reports shall be made to the
- 13 department pursuant to Subchapter C (relating to powers and
- 14 duties of department) and may be made to the appropriate child
- 15 protective service. When oral reports of suspected child abuse
- 16 are initially received at the child protective service, the
- 17 child protective service shall, after seeing to the immediate

- 1 safety of the child and other children in the home, immediately
- 2 notify the department of the receipt of the report, which is to
- 3 be held in the pending complaint file as provided in Subchapter
- 4 C. The child protective service shall notify the department of
- 5 <u>each report in which the initial report, if proven, would</u>
- 6 constitute child abuse. These would include those reports in
- 7 which the child protective service concludes, based on its
- 8 investigation conducted prior to notification of the department,
- 9 that the report of abuse is or will be unfounded. Whenever the
- 10 child protective service notifies the department of a report,
- 11 the child protective service shall obtain information regarding
- 12 whether there are any reports in the Statewide central register
- 13 or the pending complaint file containing information indicating
- 14 a prior report or a current investigation concerning a subject
- 15 of the report. If there are such records of prior reports, the
- 16 child protective service shall obtain the information permitted
- 17 to be released under section 6336(b) (relating to information in
- 18 Statewide central register). The initial child abuse report
- 19 summary shall be supplemented with a written report when a
- 20 determination is made as to whether a report of suspected child
- 21 abuse is a founded report, an unfounded report or an indicated
- 22 report.

- 24 Section 2. This act shall take effect in 90 days.
