AN ACT

- 1 Amending Title 24 (Education) of the Pennsylvania Consolidated
- 2 Statutes, further providing for contributions by the
- 3 Commonwealth, payments by employers, payments on account of
- social security deductions and payments to school districts;
- 5 and making repeals.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Sections 8326, 8327, 8329 and 8330 of Title 24 of
- 9 the Pennsylvania Consolidated Statutes are amended to read:
- 10 § 8326. Contributions by the Commonwealth.
- 11 (a) Contributions on behalf of active members.--[The] Except
- 12 as provided in subsection (c), the Commonwealth shall make
- 13 contributions into the fund on behalf of all active members in
- 14 an amount equal to one-half the amount certified by the board as
- 15 necessary to provide, together with the members' contributions,
- 16 annuity reserves on account of prospective annuities as provided
- 17 in this part in accordance with section 8328(a), (b) and (c)
- 18 (relating to actuarial cost method). In case a school employee
- 19 has elected membership in a retirement program approved by the

- 1 employer, the Commonwealth shall contribute to such program on
- 2 account of his membership an amount no greater than the amount
- 3 it would have contributed had the employee been a member of the
- 4 Public School Employees' Retirement System.
- 5 (b) Contributions on behalf of annuitants.--The Commonwealth
- 6 shall make contributions on behalf of all annuitants in an
- 7 amount equal to one-half of the amount certified by the board as
- 8 necessary to fund the additional liabilities for minimum and
- 9 supplemental annuities in accordance with section 8328(d).
- 10 (c) Members employed by school districts.--The Commonwealth
- 11 shall, on behalf of all active members employed by school
- 12 districts, pay to school districts amounts which in the
- 13 aggregate equal one-half the amount certified by the board as
- 14 necessary to provide, together with the members' contributions,
- 15 <u>annuity reserves on account of prospective annuities as provided</u>
- 16 in this part in accordance with section 8328(a), (b) and (c). In
- 17 <u>case a school employee has elected membership in a retirement</u>
- 18 program approved by the employer, the Commonwealth shall
- 19 contribute to such program on account of his membership an
- 20 <u>amount no greater than the amount it would have contributed had</u>
- 21 <u>the employee been a member of the system.</u>
- 22 § 8327. Payments by employers.
- 23 (a) General rule.--Each employer, including the Commonwealth
- 24 as employer of employees of the Department of Education, State-
- 25 owned colleges and universities, Thaddeus Stevens State School
- 26 of Technology, Pennsylvania State Oral School for the Deaf,
- 27 Scotland School for Veterans' Children, and the Pennsylvania
- 28 State University, but not including school districts, shall make
- 29 payments to the fund each quarter in an amount equal to one-half
- 30 the sum of the percentages, as determined under section 8328

- 1 (relating to actuarial cost method), applied to the total
- 2 compensation during the pay periods in the preceding quarter of
- 3 all its employees who were members of the system during such
- 4 period.
- 5 (b) Deduction from appropriations.--To facilitate the
- 6 payment of amounts due from any employer to the fund through the
- 7 State Treasurer and to permit the exchange of credits between
- 8 the State Treasurer and any employer, the Secretary of Education
- 9 and the State Treasurer shall cause to be deducted and paid into
- 10 the fund from the amount of any moneys due to any employer on
- 11 account of any appropriation for schools or other purposes such
- 12 amount due to the fund as certified by the board and as remains
- 13 unpaid on the date such appropriations would otherwise be paid
- 14 to the employer, and such amount shall be credited to the
- 15 employer's account in the fund.
- 16 (c) Compensation for employment. -- In regard to compensation
- 17 for employment after June 30, 1991, each school district shall
- 18 make payments equal to the sum of the percentages, as determined
- 19 under section 8328, applied to the total compensation during the
- 20 pay periods in the preceding quarter of all employees who were
- 21 members of the system during such period. School districts may
- 22 use amounts received under section 8326(c) (relating to
- 23 <u>contributions by the Commonwealth) to make these payments.</u>
- 24 § 8329. Payments on account of social security deductions from
- appropriations.
- 26 (a) Payments by Commonwealth.--[Where] <u>Except as provided in</u>
- 27 subsection (c), where the Secretary of Education enters into an
- 28 agreement with the Commonwealth to place under the Federal
- 29 Social Security Act members who have elected coverage, the
- 30 Commonwealth shall pay to the employers one-half of the

- 1 contributions payable under the employer's tax established by
- 2 the Social Security Act (Public Law 74-271, 42 U.S.C. § 301 et
- 3 seq.) on all covered wages which are not federally funded.
- 4 (b) Deduction from appropriations.--The Secretary of
- 5 Education and the State Treasurer are hereby authorized to cause
- 6 to be deducted and paid into or retained in the State Treasury
- 7 from any moneys due to any employer on account of appropriations
- 8 for schools or other purposes the amounts payable under the
- 9 provisions of this section.
- 10 (c) Contributions. -- Where the Secretary of Education enters
- 11 <u>into an agreement with the Commonwealth to place under the</u>
- 12 <u>Social Security Act members who are employees of school</u>
- 13 districts who have elected coverage, the Commonwealth shall pay
- 14 to school districts amounts which in the aggregate equal one-
- 15 <u>half of the contributions payable under the employer's tax</u>
- 16 <u>established by the Social Security Act on all covered wages</u>
- 17 which are not federally funded.
- 18 § 8330. Appropriations by the Commonwealth.
- 19 (a) Annual submission of budget.--The board shall prepare
- 20 and through the Governor submit annually to the General Assembly
- 21 an itemized budget consisting of the amounts necessary to be
- 22 appropriated by the Commonwealth out of the General Fund
- 23 required to meet the obligations accruing during the fiscal
- 24 period beginning July 1 of the following year.
- 25 (b) Appropriation and payment. -- The General Assembly shall
- 26 make an appropriation sufficient to provide for the obligations
- 27 of the Commonwealth. Such amount shall be paid by the State
- 28 Treasurer through the Department of Revenue into the fund within
- 29 30 days of receipt of the requisition presented each quarter by
- 30 the board. However, with respect to employees of school

- 1 districts, such amount shall be paid to school districts as
- 2 specified in sections 2502.17, 2502.18 and 2517(c) of the act of
- 3 March 10, 1949 (P.L.30, No.14), known as the Public School Code
- 4 of 1949.
- 5 Section 2. (a) The following acts or parts of acts are
- 6 repealed insofar as they establish amounts and payment schedules
- 7 for social security and retirement contributions by the
- 8 Commonwealth to school districts inconsistent with those
- 9 contribution amounts and payment schedules contained in this
- 10 act:
- 11 Section 207(c) of the act of January 5, 1952 (1951 P.L.1833,
- 12 No.491), entitled, as amended, "An act to provide for the
- 13 coverage of certain officers and employes of the Commonwealth
- 14 and its political subdivisions under the old-age and survivor
- 15 insurance provisions of Title II of the Federal Social Security
- 16 Act, as amended; creating the State Agency and conferring powers
- 17 and imposing duties upon the State Agency; authorizing the State
- 18 Agency to enter into agreements with the Federal Secretary of
- 19 Health, Education and Welfare and with political subdivisions or
- 20 instrumentalities thereof under certain terms and conditions;
- 21 providing for the Commonwealth's contribution under agreements
- 22 with the Federal Secretary of Health, Education and Welfare and
- 23 for the collection and payment of employer and employe
- 24 contributions; authorizing interstate cooperation in certain
- 25 cases, creating a Contribution Fund; and making appropriations."

- 27 (b) All other acts or parts of acts are repealed insofar as
- 28 they are inconsistent with the provisions of this act relating
- 29 to amounts and payment schedules for social security and
- 30 retirement contributions by the Commonwealth to school

- 1 districts.
- 2 Section 3. This act shall take effect as follows:
- (1) The amendment of 24 Pa.C.S § 8327 shall take effect 3
- October 1, 1991. 4
- 5 (2) The remainder of this act shall take effect in 60
- days. 6
