AN ACT

- Amending the act of December 22, 1981 (P.L.508, No.142), entitled "An act requiring the termination of certain 3 agencies of State Government under certain circumstances, creating a Leadership Committee with certain powers and 5 duties and imposing powers and duties upon the Legislative Budget and Finance Committee, "further providing for the 6 scope of the act, for powers and duties of the Leadership Committee, for evaluation of agencies, for termination of 7 8 agencies, for continuation of agencies, and for newly 9 established agencies; and eliminating provisions on 10 termination. 11
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. The definition of "agency" in section 2 of the
- 15 act of December 22, 1981 (P.L.508, No.142), known as the Sunset
- 16 Act, is amended to read:
- 17 Section 2. Definitions.
- 18 The following words and phrases when used in this act shall
- 19 have, unless the context clearly indicates otherwise, the
- 20 meanings given to them in this section:
- 21 "Agency." Any statutory authority, agency, board, bureau,
- 22 commission, committee, council, department, division, office or

- 1 any similar unit of State Government. The term shall not include
- 2 <u>an agency whose function is to provide service or management</u>
- 3 assistance to the General Assembly, which does not have the
- 4 <u>authority to administer a statute and which is not subject to</u>
- 5 <u>direction from the executive branch.</u>
- 6 * * *
- 7 Section 2. Sections 4 and 5 of the act, amended December 16,
- 8 1982 (P.L.1355, No.310), are amended to read:
- 9 Section 4. Powers and duties of the Leadership Committee.
- 10 The committee shall have the power and its duty shall be:
- 11 (1) To direct and coordinate the implementation of the
- 12 sunset review procedure.
- 13 (2) To assign the responsibility for the review and
- evaluation of each agency scheduled for such review and
- 15 evaluation under the provisions of this act to an appropriate
- standing committee of the Senate or the House of
- 17 Representatives or to appropriate standing committees of both
- 18 Houses who shall operate jointly to review and evaluate the
- 19 agency, if such joint operation is authorized by the rules of
- 20 the House and Senate. The assignments for review and
- 21 evaluation shall be made in January of the year in which the
- 22 agency is scheduled to be terminated. If any committee which
- 23 has been assigned an agency for review and evaluation fails
- 24 to complete its duties within a reasonable period of time as
- determined by the Leadership Committee, it shall be
- 26 discharged from further review or consideration of the
- 27 agency. The Leadership Committee shall then reassign the
- agency to another committee for review and evaluation
- 29 pursuant to this act.
- 30 (3) To assign tasks to the Legislative Budget and

- 1 Finance Committee for the purpose of conducting performance
- 2 audits. Such tasks shall receive priority from the
- 3 Legislative Budget and Finance Committee. The Leadership
- 4 Committee may waive, by majority vote, the requirement that
- 5 the performance audit be completed in accordance with United
- 6 States General Accounting Office standards as described in
- 7 section 2 under the following circumstances:
- 8 (i) the agency has not held any meetings or
- 9 considered any cases for a period of three years or more;
- 10 or
- 11 (ii) the agency has a budget of less than \$100,000
- annually unless the agency is a departmental board or
- 13 commission within the Bureau of Professional and
- Occupational Affairs, Department of State.
- In the event that the United States General Accounting Office
- 16 standards are waived, the Leadership Committee shall direct
- 17 the Legislative Budget and Finance Committee to complete a
- summary audit in lieu of the performance audit, and specify
- 19 the scope of such audit by September 1 of the year prior to
- the agency's termination.
- 21 [(4) To authorize, if necessary, a postponement of the
- 22 review or termination of an agency for a period not exceeding
- 23 one year.]
- 24 Section 5. Evaluation and review.
- 25 [(a) The standing committee designated by the Leadership
- 26 Committee shall develop a plan for the evaluation and review of
- 27 an agency in conjunction with the Legislative Budget and Finance
- 28 Committee and representatives of the agency being evaluated.]
- 29 (b) The standing committee shall hold at least one public
- 30 hearing for each evaluation and review of an agency. At the

- 1 hearing, the highest ranking officer of the agency or an
- 2 individual appointed by him shall bear the burden to testify
- 3 concerning the need for continued existence of the agency. The
- 4 committee shall receive other testimony at the public hearing as
- 5 it shall deem appropriate.
- 6 (c) The standing committee shall elicit information in each
- 7 evaluation and review of an agency from the Office of the
- 8 Auditor General and the Offices of Budget and Administration as
- 9 to the financial efficiency of the agency being reviewed. The
- 10 committee may request and the agency, subject to termination
- 11 shall provide such information as the committee deems pertinent
- 12 to its evaluation and review.
- 13 (d) The standing committee shall make a determination in
- 14 each evaluation and review as to whether the agency shall be
- 15 continued, altered or terminated. The committee shall base its
- 16 determination on the following criteria:
- 17 (1) whether termination would significantly harm or
- endanger the public health, safety or welfare;
- 19 (2) whether there is overlap or duplication of effort by
- other agencies that permit the termination of the agency;
- 21 (3) whether there is a more economical way of
- accomplishing the objectives of the agency;
- 23 (4) whether there is a demonstrated need, based on
- 24 service to the public, for the continuing existence of the
- agency;
- 26 (5) whether the operation of the agency has been in the
- 27 public interest;
- 28 (6) whether the agency has encouraged public
- 29 participation in the making of its rules and decisions or
- 30 whether the agency has permitted participation solely by the

- persons it regulates;
- 2 (7) whether there is an alternate, less restrictive
- 3 method of providing the same services to the public; and
- 4 (8) such other criteria as may be established by the
- 5 standing committees.
- 6 (e) Such standing committees shall draft a report concerning
- 7 each evaluation and review, stating in that report their
- 8 findings, their determination as to whether the agency should be
- 9 continued, altered or terminated, and the reasons for such a
- 10 determination together with a draft of appropriate legislation
- 11 to implement the committees' recommendations. The report shall
- 12 be available for public inspection in the Office of the
- 13 Secretary of the Senate and of the Chief Clerk of the House of
- 14 Representatives. The report shall be made to the General
- 15 Assembly on or before the first session day of September of the
- 16 year in which the agency in question is scheduled for
- 17 termination. Once the report is received by each House, the
- 18 appropriate legislation shall be introduced and referred to a
- 19 standing committee, in keeping with the rules of each House and
- 20 be acted on accordingly.
- 21 (f) On or before March 1 of the year in which the agency in
- 22 question is scheduled for termination, the standing committees
- 23 designated by the Leadership Committee as responsible for the
- 24 evaluation and review of the agency shall receive:
- 25 (1) from the Legislative Budget and Finance Committee, a
- 26 performance audit or summary audit; and
- 27 (2) from the Legislative Reference Bureau, a report
- 28 outlining all legislation, then in effect, pertaining to the
- creation, operation, duties, powers and funding of the
- 30 agency.

24	another agency scheduled for termination at an earlier date,
25	shall be subject to sunset review at the date scheduled for
26	termination of the transferee agency. However, between the time
27	at which the Legislative Budget and Finance Committee submits
28	its performance audit to the standing committee and the standing
29	committee makes its recommendation to the General Assembly, the
30	Governor shall not utilize a reorganization plan, executive

- 1 order, rule or regulation or comparable authority to transfer
- 2 any programs, activities or functions of an agency being
- 3 evaluated.
- 4 (e) The termination of any agency under this act shall serve
- 5 to terminate any advisory agency, whether created by statute or
- 6 administrative action, established for the primary purpose of
- 7 advising or assisting the terminated agency.
- 8 (f) Agencies terminated shall be given [until June 30 of the
- 9 year following the one in which they are terminated] 180 days
- 10 from the termination date to wind up their affairs. During that
- 11 period, the Governor may petition the General Assembly for a
- 12 review of the termination but the agency shall be terminated
- 13 unless the General Assembly passes a law to the contrary.
- 14 (g) The terms of office of appointees of an agency
- 15 terminated under this act shall end [on June 30 of the year
- 16 following] 180 days from the termination date.
- 17 Section 4. Sections 7 and 8 of the act, amended December 16,
- 18 1982 (P.L.1355, No.310), are amended to read:
- 19 Section 7. Reestablishment or continuation of agencies.
- 20 (a) Any agency scheduled for termination under this act, may
- 21 be reestablished by the General Assembly, by legislation. Each
- 22 reestablishment as provided in this subsection or continued as
- 23 provided in subsection (b) shall be:
- 24 (1) for a period of ten years unless otherwise specified
- in the legislation and again be subject to evaluation, review
- and termination as provided in [the] this act; and
- 27 (2) by legislation in a separate bill, in which no more
- than one agency shall be reestablished and such agency shall
- 29 be mentioned in the title of the bill.
- 30 (b) [Unless] <u>If no</u> legislation is enacted [prior to November

- 1 1,] reestablishing an agency as provided in subsection (a) by a
- 2 date 60 days prior to the termination date, the presiding
- 3 officer of each House shall cause to be placed on their
- 4 respective calendars for the first legislative day [in November]
- 5 after the date 60 days prior to the termination date, the
- 6 question, in the form of a resolution, of whether an agency
- 7 scheduled for termination [on December 31 of that year] shall be
- 8 continued. If a majority of the members elected to each House
- 9 approve such a resolution, the resolution shall be presented to
- 10 the Governor in accordance with section 9 of Article III of the
- 11 Constitution of Pennsylvania. Upon approval of the resolution in
- 12 accordance with section 15 of Article IV of the Constitution of
- 13 Pennsylvania, prior to the scheduled termination date [of
- 14 December 31], the agency shall be continued until the next
- 15 review and termination cycle scheduled for said agency.
- 16 (c) Any statute which terminates or reenacts an agency shall
- 17 control over any procedure prescribed by this act for the
- 18 continuation or termination of an agency. No statute shall be
- 19 deemed to continue an agency beyond a termination date
- 20 established for said agency pursuant to this act, unless the
- 21 statute expressly reenacts the agency in its present or altered
- 22 state.
- 23 Section 8. Newly created agencies.
- 24 [A statutory] An agency created after January 1, [1981] 1991,
- 25 shall be scheduled for termination at the conclusion of the
- 26 tenth year following its creation unless otherwise specified by
- 27 the General Assembly at its creation.
- 28 Section 5. Section 14 of the act is amended to read:
- 29 [Section 14. Expiration.
- 30 Unless the provisions of this section shall be repealed or

- amended by the General Assembly, the provisions of this act 1
- 2 shall expire at the end of ten years from the effective date of
- 3 this act.]
- Section 6. This act shall take effect immediately. 4
