## AN ACT

1 2 3 4 5 6 7 8 9	Amending the act of December 22, 1981 (P.L.508, No.142), entitled "An act requiring the termination of certain agencies of State Government under certain circumstances, creating a Leadership Committee with certain powers and duties and imposing powers and duties upon the Legislative Budget and Finance Committee," further providing for the scope of the act, for powers and duties of the Leadership Committee, for evaluation of agencies, for termination of agencies, and for termination.	<
11	The General Assembly of the Commonwealth of Pennsylvania	
12	hereby enacts as follows:	
13	Section 1. The definition of "agency" in section 2 of the	<
14	act of December 22, 1981 (P.L.508, No.142), known as the Sunset	
15	Act, is amended to read:	
16	Section 2. Definitions.	
17	The following words and phrases when used in this act shall	
18	have, unless the context clearly indicates otherwise, the	
19	meanings given to them in this section:	
20	"Agency." Any statutory authority, agency, board, bureau,	
21	commission, committee, council, department, division, office or	

- 1 any similar unit of State Government. The term shall not include
- 2 <u>an agency whose function is to provide service or management</u>
- 3 assistance to the General Assembly, which does not have the
- 4 authority to administer a statute and which is not subject to
- 5 direction from the executive branch.
- 6 \* \* \*
- 7 Section 2 1. Sections 4 and 5 of the act OF DECEMBER 22,
- 8 1981 (P.L.508, NO.142), KNOWN AS THE SUNSET ACT, amended
- 9 December 16, 1982 (P.L.1355, No.310), are amended to read:
- 10 Section 4. Powers and duties of the Leadership Committee.
- 11 The committee shall have the power and its duty shall be:
- 12 (1) To direct and coordinate the implementation of the
- 13 sunset review procedure.
- 14 (2) To assign the responsibility for the review and
- 15 evaluation of each agency scheduled for such review and
- 16 evaluation under the provisions of this act to an appropriate
- 17 standing committee of the Senate or the House of
- Representatives or to appropriate standing committees of both
- 19 Houses who shall operate jointly to review and evaluate the
- agency, if such joint operation is authorized by the rules of
- 21 the House and Senate. The assignments for review and
- 22 evaluation shall be made in January of the year in which the
- agency is scheduled to be terminated. If any committee which
- has been assigned an agency for review and evaluation fails
- 25 to complete its duties within a reasonable period of time as
- determined by the Leadership Committee, it shall be
- 27 discharged from further review or consideration of the
- 28 agency. The Leadership Committee shall then reassign the
- agency to another committee for review and evaluation
- 30 pursuant to this act.

- 1 (3) To assign tasks to the Legislative Budget and
- 2 Finance Committee for the purpose of conducting performance
- 3 audits. Such tasks shall receive priority from the
- 4 Legislative Budget and Finance Committee. The Leadership
- 5 Committee may waive, by majority vote, the requirement that
- the performance audit be completed in accordance with United
- 7 States General Accounting Office standards as described in
- 8 section 2 under the following circumstances:
- 9 (i) the agency has not held any meetings or
- 10 considered any cases for a period of three years or more;
- 11 or
- 12 (ii) the agency has a budget of less than \$100,000
- annually unless the agency is a departmental board or
- 14 commission within the Bureau of Professional and
- Occupational Affairs, Department of State.
- In the event that the United States General Accounting Office
- 17 standards are waived, the Leadership Committee shall direct
- 18 the Legislative Budget and Finance Committee to complete a
- 19 summary audit in lieu of the performance audit, and specify
- 20 the scope of such audit by September 1 of the year prior to
- 21 the agency's termination.
- [(4) To authorize, if necessary, a postponement of the
- 23 review or termination of an agency for a period not exceeding
- one year.]
- 25 Section 5. Evaluation and review.
- 26 [(a) The standing committee designated by the Leadership
- 27 Committee shall develop a plan for the evaluation and review of
- 28 an agency in conjunction with the Legislative Budget and Finance
- 29 Committee and representatives of the agency being evaluated.]
- 30 (b) The standing committee shall hold at least one public

- 1 hearing for each evaluation and review of an agency. At the
- 2 hearing, the highest ranking officer of the agency or an
- 3 individual appointed by him shall bear the burden to testify
- 4 concerning the need for continued existence of the agency. The
- 5 committee shall receive other testimony at the public hearing as
- 6 it shall deem appropriate.
- 7 (c) The standing committee shall elicit information in each
- 8 evaluation and review of an agency from the Office of the
- 9 Auditor General and the Offices of Budget and Administration as
- 10 to the financial efficiency of the agency being reviewed. The
- 11 committee may request and the agency, subject to termination
- 12 shall provide such information as the committee deems pertinent
- 13 to its evaluation and review.
- 14 (d) The standing committee shall make a determination in
- 15 each evaluation and review as to whether the agency shall be
- 16 continued, altered or terminated. The committee shall base its
- 17 determination on the following criteria:
- 18 (1) whether termination would significantly harm or
- 19 endanger the public health, safety or welfare;
- 20 (2) whether there is overlap or duplication of effort by
- other agencies that permit the termination of the agency;
- 22 (3) whether there is a more economical way of
- accomplishing the objectives of the agency;
- 24 (4) whether there is a demonstrated need, based on
- 25 service to the public, for the continuing existence of the
- 26 agency;
- (5) whether the operation of the agency has been in the
- 28 public interest;
- 29 (6) whether the agency has encouraged public
- 30 participation in the making of its rules and decisions or

- whether the agency has permitted participation solely by the
- 2 persons it regulates;
- 3 (7) whether there is an alternate, less restrictive
- 4 method of providing the same services to the public; and
- 5 (8) such other criteria as may be established by the
- 6 standing committees.
- 7 (e) Such standing committees shall draft a report concerning
- 8 each evaluation and review, stating in that report their
- 9 findings, their determination as to whether the agency should be
- 10 continued, altered or terminated, and the reasons for such a
- 11 determination together with a draft of appropriate legislation
- 12 to implement the committees' recommendations. The report shall
- 13 be available for public inspection in the Office of the
- 14 Secretary of the Senate and of the Chief Clerk of the House of
- 15 Representatives. The report shall be made to the General
- 16 Assembly on or before the first session day of September of the
- 17 year in which the agency in question is scheduled for
- 18 termination. Once the report is received by each House, the
- 19 appropriate legislation shall be introduced and referred to a
- 20 standing committee, in keeping with the rules of each House and
- 21 be acted on accordingly.
- 22 (f) On or before March 1 of the year in which the agency in
- 23 question is scheduled for termination, the standing committees
- 24 designated by the Leadership Committee as responsible for the
- 25 evaluation and review of the agency shall receive:
- 26 (1) from the Legislative Budget and Finance Committee, a
- 27 performance audit or summary audit; and
- 28 (2) from the Legislative Reference Bureau, a report
- outlining all legislation, then in effect, pertaining to the
