AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 2 special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 11 elections," further providing for the apportionment of this 12 Commonwealth into congressional districts. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 953(e) of the act of June 3, 1937 Section 1. 16 (P.L.1333, No.320), known as the Pennsylvania Election Code, 17 added March 3, 1982 (P.L.127, No.42), is amended to read: 18 Section 953. - 7 Section 2. Article XVIII-A of the act is repealed.
