# SENATE BILL No. 177 Session of 1991

### INTRODUCED BY HELFRICK, JANUARY 29, 1991

## REFERRED TO STATE GOVERNMENT, JANUARY 29, 1991

### AN ACT

Authorizing and directing the Department of General Services, 1 2 with the approval of the Governor and the Department of 3 Military Affairs, to convey to the Borough of Milton an improved tract of land situate in the Borough of Milton, 4 5 Northumberland County, Pennsylvania. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: The Department of General Services, with the 8 Section 1. 9 approval of the Governor and the Department of Military Affairs, 10 is hereby authorized and directed, on behalf of the Commonwealth 11 of Pennsylvania, to grant and convey to the Borough of Milton, 12 Northumberland County, for a consideration of one-half the fair 13 market value as determined by an independent appraiser approved 14 by the Department of Military Affairs, the following improved 15 tract of land situate in the Borough of Milton, Northumberland 16 County, Pennsylvania, bounded and described as follows: 17 All that certain lot or parcel of ground situate in the Third Ward of the Borough of Milton, Northumberland County, 18 Pennsylvania, bounded and described as follows, to wit: 19

1 Beginning at a point on the east side of Ridge Avenue, which point is at the southwest corner of lands of Shimer Hose 2 3 Company, and running thence along said Shimer Hose Company 4 lands, south 84 degrees 28.25 minutes east a distance of 150 5 feet to a stake; thence along other lands of Milton Borough School District, south 05 degrees 26.50 minutes west a distance 6 of 150 feet to a stake; thence along other lands of Milton 7 Borough School District, north 84 degrees 28.25 minutes west a 8 distance of 150 feet to Ridge Avenue; and thence along the east 9 10 side of Ridge Avenue, north 05 degrees 26.50 minutes east a 11 distance of 150 feet to the place of beginning.

12 Section 2. The conveyance shall be made under and subject to 13 all easements, servitudes and rights of others, including, but 14 not confined to, streets, roadways and rights of telephone, 15 telegraph, water, electric, sewer, gas or pipeline companies, as 16 well as under and subject to any interest, estates or tenancies 17 vested in third persons, whether or not appearing of record, for 18 any portion of the land or improvements erected thereon. 19 Section 3. The deed of conveyance shall be approved as 20 provided by law and shall be executed by the Secretary of General Services in the name of the Commonwealth of 21 22 Pennsylvania.

23 Section 4. The deed of conveyance shall contain a clause 24 that the lands conveyed shall be used for municipal purposes by 25 the Borough of Milton and, if at any time the Borough of Milton 26 or its successor in function conveys said property or permits 27 said property to be used for any purpose other than that 28 aforementioned, the title thereto shall immediately revert to 29 and revest in the Commonwealth of Pennsylvania.

30 Section 5. The deed of conveyance shall contain a clause 19910S0177B0186 - 2 - providing that the owner will rehabilitate and maintain the property in accordance with the approaches in "The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings (U.S. Department of the Interior, National Park Service, 1983)."

6 Section 6. Costs and fees incidental to this conveyance7 shall be borne by the grantee.

8 Section 7. This act shall take effect immediately.
