- 3 (A) ESTABLISHMENT.--THERE IS ESTABLISHED THE PENNSYLVANIA
- 4 VETERANS' MEMORIAL COMMISSION TO ERECT ON THE GROUNDS OF THE
- 5 INDIANTOWN GAP NATIONAL CEMETERY AN APPROPRIATELY PATRIOTIC AND
- 6 POSITIVE PHYSICAL MONUMENT OR MEMORIAL AS A TESTAMENT OF
- 7 APPRECIATION FROM THE COMMONWEALTH TO THOSE PENNSYLVANIA SERVICE
- 8 PERSONS WHO SERVED IN ARMED CONFLICTS IN WHICH THE UNITED STATES
- 9 WAS A PARTICIPANT.
- 10 (B) COMPOSITION OF COMMISSION. -- THE COMMISSION SHALL BE
- 11 COMPOSED OF THE FOLLOWING:
- 12 (1) TWO MEMBERS OF THE SENATE TO BE APPOINTED BY THE
- PRESIDENT PRO TEMPORE OF THE SENATE, ONE FROM THE MAJORITY
- 14 PARTY AND ONE FROM THE MINORITY PARTY. PREFERENCE SHALL BE
- 15 GIVEN TO HONORABLY DISCHARGED VETERANS.
- 16 (2) TWO MEMBERS OF THE HOUSE OF REPRESENTATIVES TO BE
- 17 APPOINTED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, ONE
- 18 FROM THE MAJORITY PARTY AND ONE FROM THE MINORITY PARTY.
- 19 PREFERENCE SHALL BE GIVEN TO HONORABLY DISCHARGED VETERANS.
- 20 (3) THE SECRETARY OF GENERAL SERVICES, OR A DESIGNEE.
- 21 (4) THE EXECUTIVE DIRECTOR OF THE PENNSYLVANIA
- 22 HISTORICAL AND MUSEUM COMMISSION, OR A DESIGNEE.
- 23 (5) ONE MEMBER, APPOINTED BY THE GOVERNOR, WHO MUST BE
- 24 AN ARCHITECT.
- 25 (6) FIVE MEMBERS, APPOINTED BY THE GOVERNOR, WHO MUST BE
- 26 PENNSYLVANIA VETERANS. AT LEAST ONE OF THESE MEMBERS MUST BE
- 27 A WOMAN.
- 28 (7) THE COMMANDER OF THE PENNSYLVANIA WAR VETERAN'S
- 29 COUNCIL, OR A DESIGNEE.
- 30 (8) THE STATE ADJUTANT OF THE PENNSYLVANIA VETERANS OF

- 1 FOREIGN WARS, OR A DESIGNEE.
- 2 (9) THE PENNSYLVANIA STATE COMMANDER OF THE DISABLED
- 3 AMERICAN VETERANS, OR A DESIGNEE.
- 4 (10) THE STATE ADJUTANT OF THE PENNSYLVANIA AMERICAN
- 5 LEGION, OR A DESIGNEE.
- 6 (11) THE ADJUTANT GENERAL OF THE DEPARTMENT OF MILITARY
- 7 AFFAIRS, OR A DESIGNEE.
- 8 (12) THE DIRECTOR OF THE BUREAU OF VETERANS AFFAIRS IN
- 9 THE DEPARTMENT OF MILITARY AFFAIRS.
- 10 (13) ONE MEMBER, APPOINTED BY THE GOVERNOR, WHO MUST BE
- 11 A CERTIFIED PUBLIC ACCOUNTANT.
- 12 (C) TERMS.--ALL MEMBERS SHALL SERVE FOR A PERIOD OF THREE
- 13 YEARS FROM THE DATE OF THEIR APPOINTMENT, EXCEPT THAT NO MEMBER
- 14 APPOINTED UNDER SUBSECTION (B)(1), (2), (3), (4), (7), (8), (9),
- 15 (10), (11) OR (12) SHALL SERVE PAST THE DATE OF EXPIRATION OF
- 16 OFFICE.
- 17 (D) VACANCIES.--VACANCIES IN THE MEMBERSHIP OF THE
- 18 COMMISSION SHALL BE FILLED IN THE SAME MANNER AS THE ORIGINAL
- 19 APPOINTMENT.
- 20 (E) ORGANIZATION AND PROCEDURE. --
- 21 (1) THE COMMISSION SHALL ELECT, BY A MAJORITY OF ALL ITS
- 22 MEMBERS, A CHAIRMAN, VICE CHAIRMAN AND A SECRETARY FROM AMONG
- 23 ITS MEMBERS, EACH TO SERVE FOR A TERM OF THREE YEARS.
- 24 (2) A MAJORITY OF ALL MEMBERS OF THE COMMISSION SHALL
- 25 CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS.
- 26 (3) THE COMMISSION MAY ADOPT RULES FOR ITS GOVERNMENT,
- 27 ORGANIZATION AND PROCEDURES, NOT INCONSISTENT WITH THE
- 28 PROVISIONS OF THIS CHAPTER.
- 29 (F) EXPENSES.--COMMISSION MEMBERS SHALL RECEIVE NO
- 30 COMPENSATION FOR THEIR SERVICES BUT SHALL BE REIMBURSED BY THE

- 1 DEPARTMENT FOR ALL NECESSARY TRAVEL AND OTHER REASONABLE
- 2 EXPENSES INCURRED IN CONNECTION WITH THE PERFORMANCE OF THEIR
- 3 DUTIES AS MEMBERS OF THE COMMISSION.
- 4 (G) ADMINISTRATIVE SERVICES.--THE DEPARTMENT SHALL PROVIDE
- 5 ADMINISTRATIVE STAFF, SUPPORT AND SERVICES TO THE COMMISSION ON
- 6 AN ONGOING BASIS.
- 7 § 1904. DUTIES OF COMMISSION.
- 8 IN ADDITION TO OTHER POWERS CONFERRED BY THIS CHAPTER, THE
- 9 COMMISSION SHALL HAVE THE POWER:
- 10 (1) TO ERECT A PHYSICAL MONUMENT TO BE LOCATED ON THE
- GROUNDS OF THE INDIANTOWN GAP NATIONAL CEMETERY HONORING
- 12 PENNSYLVANIA VETERANS.
- 13 (2) TO RECEIVE FOR AND ON BEHALF OF THE COMMONWEALTH,
- 14 MONETARY GIFTS OR BEQUESTS WHICH SHALL BE DEPOSITED IN THE
- 15 FUND.
- 16 (3) TO ACCEPT GRANTS AND SUBSIDIES FROM AND ENTER INTO
- 17 AGREEMENTS OR OTHER TRANSACTIONS WITH ANY FEDERAL AGENCY OR
- 18 AGENCY OF THE COMMONWEALTH OR OTHER ENTITY.
- 19 (4) TO ENTER INTO CONTRACTS AND TO EXECUTE ALL
- 20 INSTRUMENTS NECESSARY OR CONVENIENT FOR CARRYING ON ITS
- 21 OPERATIONS.
- 22 (5) TO ISSUE APPROPRIATE REGULATIONS FOR THE
- 23 IMPLEMENTATION OF THIS CHAPTER.
- 24 (6) TO DO ALL OTHER THINGS NECESSARY OR CONVENIENT TO
- 25 CARRY OUT THE POWERS GRANTED TO IT BY THIS CHAPTER.
- 26 § 1905. PENNSYLVANIA VETERANS' MEMORIAL TRUST FUND.
- 27 (A) ESTABLISHMENT AND ADMINISTRATION.--THERE IS HEREBY
- 28 ESTABLISHED A SEPARATE FUND IN THE STATE TREASURY TO BE KNOWN AS
- 29 THE PENNSYLVANIA VETERANS' MEMORIAL TRUST FUND. THE FUND SHALL
- 30 BE ADMINISTERED BY THE COMMISSION, AND ALL MONEYS IN THE FUND

- ARE APPROPRIATED TO THE COMMISSION ON A CONTINUING BASIS.
- (B) PURPOSE.--THE MONEYS IN THE FUND SHALL BE USED FOR THE 2
- 3 SELECTION, DESIGN AND CONSTRUCTION OF AN APPROPRIATE PHYSICAL
- MONUMENT ON THE GROUNDS OF THE INDIANTOWN GAP NATIONAL CEMETERY
- 5 AND OTHER COSTS INCIDENTAL THERETO.
- 6 (C) CONTRIBUTIONS AND SOLICITATION OF FUNDS. --
- 7 (1) THE COMMISSION IS AUTHORIZED:
- 8 (I) TO ACCEPT, ON BEHALF OF THE COMMONWEALTH, GIFTS,
- DONATIONS, LEGACIES AND USAGES OF MONEY FROM INDIVIDUALS, 9
- ORGANIZATIONS, PUBLIC OR PRIVATE CORPORATIONS AND OTHER 10
- 11 SIMILAR ENTITIES.
- (II) TO SOLICIT AND RAISE MONEYS FROM PUBLIC AND 12
- 13 PRIVATE SOURCES.
- 14 (2) ALL MONEY RECEIVED OR RAISED UNDER THIS SUBSECTION
- 15 SHALL BE PAID INTO THE STATE TREASURY AND CREDITED TO THE
- 16 FUND.
- 17 § 1906. EXPIRATION OF CHAPTER.
- 18 THIS CHAPTER SHALL EXPIRE JUNE 30, 1995.
- 19 Section 3. This act shall be retroactive to June 30, 1992,
- 20 if enacted after that date.
- Section 4. This act shall take effect immediately. 21
