AN ACT

- 1 Amending Title 24 (Education) of the Pennsylvania Consolidated
- 2 Statutes, further providing for credited school service and
- 3 for termination of annuities.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 8302 of Title 24 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subsection to read:
- 8 § 8302. Credited school service.
- 9 * * *
- 10 (b.2) Credited service as retirement incentive.--
- 11 Notwithstanding any provisions of this title to the contrary,
- 12 for the period of July 1, 1992, to August 31, 1993, a member who
- 13 is not an annuitant on July 1, 1992, who terminates school
- 14 service between July 1, 1992, and August 31, 1993, inclusive,
- 15 who will be 55 years of age or older on August 31, 1993, with
- 16 ten or more eligibility points, and who files an application for <-
- 17 retirement before September 1, 1993, AND WHO DECLARES HIS INTENT <---
- 18 TO RETIRE PRIOR TO APRIL 1, 1993, shall be credited with an

- 1 additional 10% of their credited service.

- 3 Section 2. Section 8346(a) of Title 24 is amended to read:
- 4 § 8346. Termination of annuities.
- 5 (a) General rule.--If an annuitant returns to school service
- 6 or enters State service and elects multiple service membership,
- 7 any annuity payable to him under this part shall cease and in
- 8 the case of an annuity other than a disability annuity the
- 9 present value of such annuity, adjusted for full coverage in the
- 10 case of a joint coverage member who makes the appropriate back
- 11 contributions for full coverage, shall be frozen as of the date
- 12 such annuity ceases. An annuitant who is credited with an
- 13 additional 10% of membership service as provided in section
- 14 8302(b.1) (relating to credited school service) and who returns
- 15 to school service, except as provided in subsection (b) shall
- 16 <u>forfeit such credited service and shall have his frozen present</u>
- 17 value adjusted as if his 10% retirement incentive had not been
- 18 applied to his account. In the event that the cost-of-living
- 19 increase enacted December 18, 1979 occurred during the period of
- 20 such State or school employment, the frozen present value shall
- 21 be increased, on or after the member attains superannuation age,
- 22 by the percent applicable had he not returned to service.

- 24 Section 3. This act shall take effect immediately.
