AN ACT

- Amending the act of June 22, 1931 (P.L.682, No.249), entitled, 2 as amended, "An act relating to birds, fowl and domestic 3 animals, and providing for their appraisement when condemned to prevent the spread of disease; and regulating payments by 4 the Commonwealth in such cases, and the payment of salvage by butchers, "further defining "domestic animal" or "animal"; 6 7 and further providing for compensation of owners of domestic animals. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Sections 1 and 2 of the act of June 22, 1931 12 (P.L.682, No.249), referred to as the Diseased Animal 13 Condemnation Law, amended October 10, 1974 (P.L.680, No.227), are amended to read: 14 15 Section 1. Be it enacted, &c., That the word "salvage," as

- 19 The word "condemned," as used in this act, means that a
- 20 domestic animal has been adjudged, by an authorized officer or

- 1 agent of the Department of Agriculture, to be diseased and
- 2 ordered to be slaughtered to prevent the spread of disease.
- 3 The phrase "domestic animal" or "animal," as used in this
- 4 act, includes a bird or fowl or any wild or semiwild animal held <-
- 5 <u>in captivity</u> OR ANY EQUINE ANIMAL OR BOVINE ANIMAL, SHEEP, GOAT, <---
- 6 PIG, DOG, CAT OR POULTRY OR ANY WILD OR SEMIWILD ANIMAL HELD IN
- 7 CAPTIVITY, unless the context clearly indicates otherwise.
- 8 THE PHRASE "WILD OR SEMIWILD ANIMAL," AS USED IN THIS ACT,
- 9 INCLUDES A DOMESTIC ANIMAL WHICH IS NOW OR HISTORICALLY HAS BEEN
- 10 FOUND IN THE WILD, INCLUDING, BUT NOT LIMITED TO, BISON, DEER,
- 11 ELK, LLAMAS OR ANY SPECIES OF FOREIGN OR DOMESTIC CATTLE, SUCH
- 12 AS ANKOLE, GAYAL AND YAK.
- 13 Section 2. The Commonwealth hereby agrees to compensate
- 14 owners of domestic animals condemned to prevent the spread of
- 15 disease. Such compensation shall be determined as follows:
- 16 (a) The amount of compensation paid by the Commonwealth,
- 17 together with the salvage and any compensation received by the
- 18 owner from other sources, shall not in any case exceed ninety
- 19 percent of the appraised value of the animal; [and]
- 20 (b) The amount of compensation paid by the Commonwealth
- 21 shall be sixty-seven percent of the appraised value for a horse,
- 22 jack, mule, bovine animal, sheep, or swine, except that in no
- 23 event shall any such compensation exceed the sum of one thousand
- 24 dollars (\$1,000) per head of cattle or bison; three hundred
- 25 dollars (\$300) per horse, jack, mule, or head of swine; one
- 26 hundred dollars (\$100) per sheep or goat; except that in no case
- 27 shall compensation paid by the Commonwealth exceed the sum of
- 28 one hundred thousand dollars (\$100,000) for any herd OR FLOCK of <-
- 29 animals[.]; and
- 30 (c) The amount of compensation paid by the Commonwealth for

- 1 any wild or semiwild animal in captivity and condemned by the
- 2 Department of Agriculture to prevent the spread of disease shall
- 3 be no more than three hundred dollars (\$300) per animal or
- 4 sixty-seven percent of the appraised value of the animal,
- 5 whichever is less, except that in no case shall the compensation
- 6 paid by the Commonwealth exceed the sum of one hundred thousand

- 7 dollars (\$100,000) for any herd OR FLOCK of animals.
- 8 The Secretary of Agriculture may authorize payment of
- 9 indemnity for tuberculosis and/or brucellosis and/or Johne's
- 10 disease in bovine animals which have been found to be exposed,
- 11 is a part of a known infected herd, and it has been determined
- 12 by the herd owner's veterinarian and the Director of the Bureau
- 13 of Animal Industry in the Department of Agriculture that
- 14 destruction of all the cattle or bison in the herd will
- 15 contribute to the tuberculosis and/or brucellosis and/or Johne's
- 16 disease eradication program, provided that the joint State-
- 17 Federal indemnity payments, plus salvage, does not exceed ninety
- 18 percent of the appraised value of the animal.
- 19 Swine affected with or exposed to hog cholera, which has been
- 20 confirmed by an official laboratory of the Pennsylvania Bureau
- 21 of Animal Industry, and which are to be destroyed to prevent
- 22 further spread of the disease, shall be appraised at their
- 23 actual value for meat, feeding, or breeding purposes at the
- 24 place and time of appraisal, except that in the case of grade
- 25 animals only females shall be eligible for appraisal based on
- 26 breeding value and that no such appraisal shall exceed three
- 27 times the animal's meat or feeding value.
- 28 Claims for purebred registered animals shall be supported by
- 29 proper certificates of registration and transfer papers issued
- 30 by recognized purebred registry associations.

1 Section 2. This act shall take effect in 60 days.
