## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, providing for a speed limit of 65 miles per hour on
- 3 rural interstate highways and on a certain portion of the
- 4 Pennsylvania Turnpike; and further providing for speed timing
- 5 devices.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Sections 3362, 3368(c) and 6110(a) of Title 75 of
- 9 the Pennsylvania Consolidated Statutes are amended to read:
- 10 § 3362. Maximum speed limits.
- 11 (a) General rule.--Except when a special hazard exists that
- 12 requires lower speed for compliance with section 3361 (relating
- 13 to driving vehicle at safe speed), the limits specified in this
- 14 [subsection] section or established under this subchapter shall
- 15 be maximum lawful speeds and no person shall drive a vehicle at
- 16 a speed in excess of the following maximum limits:
- 17 (1) 35 miles per hour in any urban district.
- 18 (2) 55 miles per hour in other locations.
- 19 (3) Any other maximum speed limit established under this

- 1 subchapter.
- 2 (a.1) Limit on certain highways. -- Notwithstanding subsection
- 3 (a), the speed limit, for passenger cars only, on rural
- 4 <u>interstate highways and the east-west portion of the</u>
- 5 Pennsylvania Turnpike outside of an urbanized area with a
- 6 population of 50,000 or more shall be 65 miles per hour.
- 7 (b) Posting of speed limit. -- No maximum speed limit
- 8 established under subsection (a)(1) or (3) shall be effective
- 9 unless posted on fixed or variable official traffic-control
- 10 devices erected in accordance with regulations adopted by the
- 11 department which regulations shall require posting at the
- 12 beginning and end of each speed zone and at intervals not
- 13 greater than one-half mile.
- 14 (c) Penalty.--Any person violating this section is guilty of
- 15 a summary offense and shall, upon conviction, be sentenced to
- 16 pay a fine of \$35. Any person exceeding the maximum speed limit
- 17 by more than five miles per hour shall pay an additional fine of
- 18 \$2 per mile for each mile in excess of five miles per hour over
- 19 the maximum speed limit.
- 20 (d) Rural interstate highways. -- The department shall
- 21 <u>determine what constitutes a rural interstate highway. The</u>
- 22 determination shall be based on the population of the area in
- 23 which the highway is located as specified in 23 U.S.C. § 154
- 24 (relating to national maximum speed limit). A section of an
- 25 interstate highway may be designated as rural and, on the
- 26 approval of the department that the highway meets minimum design
- 27 criteria and safety standards, the speed limit of that section
- 28 may be set at 65 miles per hour, even though another portion of
- 29 that highway, because it is located in an area of dense
- 30 population, is not designated as rural and the speed limit on

- 1 that section is 55 miles per hour.
- 2 § 3368. Speed timing devices.
- 3 \* \* \*
- 4 (c) Mechanical, electrical and electronic devices
- 5 authorized.--
- 6 (1) Except as otherwise provided in this section, the
- 7 rate of speed of any vehicle may be timed on any highway by a
- 8 police officer using a mechanical or electrical speed timing
- 9 device.
- 10 (2) Except as otherwise provided in paragraph (3),
- 11 electronic devices such as radio-microwave devices (commonly
- 12 referred to as electronic speed meters or radar) may be used
- only by members of the Pennsylvania State Police.
- 14 (3) Electronic devices which calculate speed by
- 15 measuring elapsed time between measured road surface points
- by using two sensors and devices which measure and calculate
- the average speed of a vehicle between any two points may be
- 18 used by any police officer.
- 19 (4) No person may be convicted upon evidence obtained
- 20 through the use of devices authorized by paragraphs (2) and
- 21 (3) unless the speed recorded is six or more miles per hour
- in excess of the legal speed limit or two or more miles per
- 23 hour in excess of the legal speed limit in an area where the
- 24 <u>maximum speed limit is 65 miles per hour</u>. Furthermore, no
- 25 person may be convicted upon evidence obtained through the
- use of devices authorized by paragraph (3) in an area where
- 27 the legal speed limit is less than 55 miles per hour if the
- 28 speed recorded is less than ten miles per hour in excess of
- the legal speed limit. This paragraph shall not apply to
- 30 evidence obtained through the use of devices authorized by

- 1 paragraph (3) within a school zone.

- 3 § 6110. Regulation of traffic on Pennsylvania Turnpike.
- 4 (a) General rule. -- The provisions of this title apply upon
- 5 any turnpike or highway under the supervision and control of the
- 6 Pennsylvania Turnpike Commission unless specifically modified by
- 7 rules and regulations promulgated by the commission which shall
- 8 become effective only upon publication in accordance with law. A
- 9 copy of the rules and regulations, so long as they are
- 10 effective, shall be posted at all entrances to the turnpike or
- 11 highway for the inspection of persons using the turnpike or
- 12 highway. This section does not authorize the establishment of a
- 13 maximum speed limit greater than 55 miles per hour on any
- 14 portion of the Pennsylvania Turnpike not outside of an urbanized
- 15 <u>area with a population of 50,000 or more. Any maximum speed</u>
- 16 <u>limit greater than 55 miles per hour is subject to the approval</u>
- 17 of the commission that the portion of the turnpike where the
- 18 greater speed limit will be in effect meets minimum design
- 19 criteria and safety standards.

- 21 Section 2. This act shall take effect immediately.
