AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, increasing monetary limits of
- 3 liability.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 5505(a) and (b) of Title 23 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 5505. Monetary limits of liability.
- 9 (a) General rule.--Liability of the parents under this
- 10 chapter shall be limited to:
- 11 (1) The sum of [\$300] \$1,500 for injuries suffered by
- 12 any one person as a result of one tortious act or continuous
- 13 series of tortious acts.
- 14 (2) The sum of [\$1,000] \$5,000 regardless of the number
- of persons who suffer injury as a result of one tortious act

- 1 or continuous series of tortious acts.
- 2 (b) Proceedings where loss exceeds liability.--In the event
- 3 that actual loss as ascertained by the court or the judgment
- 4 against the child exceeds [\$1,000] \$5,000, the parents shall be
- 5 discharged from further liability by the payment of [\$1,000]
- 6 \$5,000 into court. The court shall cause all aggrieved parties
- 7 to submit itemized statements of loss in writing and shall make
- 8 distribution proportionately, whether the claims be for injuries
- 9 to the person or for theft, destruction or loss of property. The
- 10 court may take testimony to assist it in making proper
- 11 distribution and may appoint a master to accomplish this
- 12 purpose. All costs and fees incurred in these proceedings shall
- 13 be paid from the [\$1,000] \$5,000 paid into court.

- 15 Section 2. This act shall take effect in 60 days.
