AN ACT

Amending the act of November 30, 1965 (P.L.847, No.356), 1 entitled "An act relating to and regulating the business of banking and the exercise by corporations of fiduciary powers; 2 3 4 affecting persons engaged in the business of banking and 5 corporations exercising fiduciary powers and affiliates of such persons; affecting the shareholders of such persons and 6 7 the directors, trustees, officers, attorneys and employes of 8 such persons and of the affiliates of such persons; affecting 9 national banks located in the Commonwealth; affecting persons dealing with persons engaged in the business of banking, 10 corporations exercising fiduciary powers and national banks; 11 12 conferring powers and imposing duties on the Banking Board, 13 on certain departments and officers of the Commonwealth and 14 on courts, prothonotaries, clerks and recorders of deeds; 15 providing penalties; and repealing certain acts and parts of acts," providing for the observation of Jefferson's birthday. 16

17 The General Assembly of the Commonwealth of Pennsylvania

18 hereby enacts as follows:

Section 1. Section 113(b) of the act of November 30, 1965 (P.L.847, No.356), known as the Banking Code of 1965, amended December 18, 1990 (P.L.766, No.191), is amended to read: Section 113. Legal Holidays 1 * * *

2 (b) Optional holidays--An institution may at its option3 observe as a legal holiday:

(i) Lincoln's Birthday (February 12); 4 5 (ii) Washington's Birthday (the third Monday in 6 February); 7 (iii) Good Friday; 8 (iv) Flaq Day (June 14); 9 (v) Columbus Day (the second Monday in October); (vi) Election Day (the first Tuesday after the first 10 11 Monday in November); 12 (vii) Veterans' Day (November 11); 13 (viii) each Saturday either as a half-holiday after 12 o'clock noon or as a full holiday; 14 15 (ix) each Monday following an Independence Day, a 16 Christmas Day or New Year's Day which occurs on a Saturday; 17 [and] 18 (x) each day which the department permits all institutions by public announcement, or an individual 19 20 institution by written permission, to observe as a legal 21 holiday[.]; and (xi) Jefferson's Birthday (April 13). 22 * * * 23 24 Section 2. This act shall take effect immediately.
