## AN ACT

- 1 Establishing the Keystone Card program; providing for powers and
- duties of the Department of Aging and for the functioning of
- 3 the program; and making an appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Keystone Card
- 8 Act.
- 9 Section 2. Legislative intent.
- 10 The General Assembly finds and declares as follows:
- 11 (1) The Commonwealth has a duty and responsibility for
- the well-being of its people.
- 13 (2) The Commonwealth has been and is in a period of
- economic recession, making the purchase of necessary goods
- 15 and services difficult.
- 16 (3) Certain citizens, particularly senior citizens who

- 1 are on fixed incomes, have been especially hard hit by the
- 2 economic downturn.
- 3 (4) It is in the interest of the Commonwealth to assist,
- 4 when possible, its senior citizens by:
- 5 (i) enhancing their purchasing power through
- 6 benefits or discounts for goods and services provided by
- 7 participating Commonwealth businesses; and
- 8 (ii) forging partnerships among Commonwealth
- 9 businesses and senior citizens.
- 10 Section 3. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- "Card." The Keystone Card.
- 15 "Department." The Department of Aging of the Commonwealth.
- 16 "Program." The Keystone Card program.
- 17 Section 4. Keystone Card program.
- 18 (a) Establishment.--There is hereby established the Keystone
- 19 Card program to be administered by the Department of Aging.
- 20 (b) Eligibility.--Any citizen of this Commonwealth who is 60
- 21 years of age or older is eligible to participate in the program.
- 22 (c) Nontransferable.--Any card that the department issues
- 23 shall be held in perpetuity by the original cardholder and shall
- 24 not be transferable to any other person.
- 25 (d) Lost card.--A person who loses his card may obtain
- 26 another card from the department at the cost of replacement upon
- 27 providing the same information to the department as was required
- 28 for the issuance of the original card.
- 29 (e) Needs-testing.--Needs-testing to determine eligibility
- 30 is forbidden.

- 1 Section 5. Powers and duties of department.
- 2 The department shall:
- 3 (1) Encourage support and participation in the program
- 4 by all persons, including governmental organizations.
- 5 (2) Prevent the issuance of cards to persons not
- 6 qualified to have them.
- 7 (3) Require the card to contain the signature of the
- 8 cardholder and any other information the department
- 9 determines is necessary.
- 10 (4) Bear the cost of administering the program.
- 11 Section 6. Functioning of program.
- 12 The program shall function as follows:
- 13 (1) Cardholders shall be entitled to any benefits
- granted to them by private persons or organizations, the laws
- of the Commonwealth or ordinances or resolutions of political
- 16 subdivisions.
- 17 (2) A person or organization is not required to provide
- 18 benefits to any cardholder.
- 19 (3) All discounts or benefits offered by persons or
- 20 organizations to cardholders shall be based on the regularly
- offered price for goods and services.
- 22 (4) Participation in the program is entirely voluntary.
- 23 (5) No person shall use a card except to obtain a
- 24 benefit for the holder of the card to which the holder is
- entitled under the conditions of the offer.
- 26 (6) Any person or organization found in violation of
- 27 this act shall be terminated from the program and not
- 28 entitled to any further participation.
- 29 Section 7. Rules and regulations.
- The department shall promulgate rules and regulations

- 1 necessary to carry out the purposes of this act.
- 2 Section 8. Appropriation.
- 3 The sum of \$1,000,000, or as much thereof as may be
- 4 necessary, is hereby appropriated to the Department of Aging for
- 5 the fiscal year July 1, 1993, to June 30, 1994, to carry out the
- 6 provisions of this act.
- 7 Section 9. Effective date.
- 8 This act shall take effect in 30 days.
