AN ACT

- 1 Authorizing and directing the Department of Transportation, with
- 2 the approval of the Governor, to convey to the Borough of
- 3 Freemansburg a tract of land situate in the Borough of
- 4 Freemansburg, Northampton County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The Department of Transportation, with the
- 8 approval of the Governor, is hereby authorized and directed, on
- 9 behalf of the Commonwealth, to grant and convey FOR \$1 by
- 10 quitclaim deed to the Borough of Freemansburg, Northampton
- 11 County, the parcel of land described in section 2.
- 12 Section 2. A parcel located on the east side of S.R. 3005
- 13 (Main Street), between stations 15+82 and 17+98, more or less
- 14 triangular in shape, and containing 0.297 acres, as shown on a
- 15 property plat of the Department of Transportation for
- 16 Legislative Route 3005, section 01B R/W, Northampton County,
- 17 Parcel Nos. 5 and 6, sheet Nos. 8 and 9, Claim Nos. 4803295-97
- 18 and 4803296-97.

- 1 Section 3. The deed authorized herein shall reserve to the
- 2 grantor a ten-feet-wide underground drain pipe easement from the
- 3 east side of the legal right of way line of S.R. 3005, section
- 4 01B, to the easterly property line, containing 679.75 square
- 5 feet, as shown on the property plat described in section 2.
- 6 Section 4. The conveyance shall be made under and subject to
- 7 all easements, servitudes and rights of others, including, but
- 8 not confined to, streets, roadways and rights of any telephone,
- 9 telegraph, water, electric, sewer, gas or pipeline companies, as
- 10 well as under and subject to any interest, estates or tenancies
- 11 vested in third persons, whether or not appearing of record, for
- 12 any portion of the land or improvements erected thereon.
- 13 Section 5. The deed of conveyance shall contain a clause
- 14 that the property conveyed shall be used for municipal purposes
- 15 by the Borough of Freemansburg, and, if at any time the Borough
- 16 of Freemansburg or its successor in function sells or transfers
- 17 the property or permits the property to be used for any purpose
- 18 other than those specified in this section, the title to the
- 19 property shall immediately revert to and revest in the
- 20 Commonwealth of Pennsylvania.
- 21 Section 6. The deed of conveyance shall be approved as
- 22 provided by law and shall be executed by the Secretary of
- 23 Transportation in the name of the Commonwealth of Pennsylvania.
- 24 Section 7. Costs and fees incidental to this conveyance
- 25 shall be borne by the grantee.
- 26 Section 8. This act shall take effect immediately.
