AN ACT

- 1 Providing for hours of solicitation of contributions from senior
- 2 citizens; and providing for notification of Department of
- 3 Aging of certain contributions.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Definitions.
- 7 The following words and phrases when used in this act shall
- 8 have the meanings given to them in this section unless the
- 9 context clearly indicates otherwise:
- 10 "Contribution." The promise, grant or pledge of money,
- 11 credit, property, financial assistance or other thing of any
- 12 kind or value in response to a solicitation, including the
- 13 payment or promise to pay in consideration of a performance,
- 14 event or sale of a good or service. Payment by members of an
- 15 organization for membership fees, dues, fines or assessments or
- 16 for services rendered to individual members, if the fees, dues,

- 1 fines or assessments confer a bona fide right, privilege,
- 2 professional standing, honor or other direct benefit, shall not
- 3 be deemed contributions, provided that membership is not
- 4 conferred solely as consideration for making a contribution in
- 5 response to a solicitation.
- 6 "Person." Any individual, organization, corporation,
- 7 association, partnership, trust, foundation or any other entity
- 8 however styled.
- 9 "Senior citizen." A person who is 65 years of age or older.
- 10 Section 2. Hours of solicitation.
- 11 A senior citizen may not be solicited for contributions at
- 12 his residence between 9:00 p.m. and 9:00 a.m. by any person.
- 13 Section 3. Notification of Department of Aging.
- 14 A senior citizen who has made a contribution exceeding \$500
- 15 may cancel the contribution by notifying the soliciting person
- 16 or organization within five days, and the soliciting person or
- 17 organization shall return the contribution within ten days.
- 18 Section 4. Civil action by Department of Aging.
- 19 The Department of Aging may bring a civil action on behalf of
- 20 a senior citizen to enforce the provisions of section 3.
- 21 Section 5. Penalty.
- 22 Any person who willfully and knowingly violates any provision
- 23 of this act commits a misdemeanor of the first degree and shall,
- 24 upon conviction, be sentenced to pay a fine of not more than
- 25 \$10,000 or to imprisonment for not more than five years, or
- 26 both.
- 27 Section 6. Effective date.
- This act shall take effect in 60 days.
