## AN ACT

- 1 Establishing the Education Plus Program and providing for its operation; and making an appropriation.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Education
- 7 Plus Program Act.
- 8 Section 2. Legislative intent.
- 9 The General Assembly finds and declares that it is the
- 10 purpose of this act to encourage partnerships between
- 11 institutions of higher education and secondary schools serving
- 12 low-income and disadvantaged students and encourage the support
- 13 and participation of programs that do the following:
- (1) Improve the retention and graduation rates at
- 15 secondary schools.
- 16 (2) Improve the academic skills of public secondary
- 17 school students.

- 1 (3) Increase the students' opportunities to continue a
- 2 program of education after secondary school.
- 3 (4) Improve the students' prospects for employment after
- 4 secondary school.
- 5 Section 3. Definitions.
- 6 The following words and phrases when used in this act shall
- 7 have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 "Department." The Department of Education of the
- 10 Commonwealth.
- 11 "First-generation college student." An individual whose
- 12 parents did not complete a baccalaureate degree or an individual
- 13 whose parent did not complete a baccalaureate degree if the
- 14 individual regularly resided with and received support from only
- 15 one parent.
- 16 "Low-income individual." An individual from a family which
- 17 is eligible for participation in the United States Aid to
- 18 Families with Dependent Children Program as determined by the
- 19 Department of Public Welfare.
- 20 "Low-income school district." A school district where low-
- 21 income individuals comprise more than 45% of the student
- 22 population.
- 23 "Secretary." The Secretary of Education of the Commonwealth.
- 24 Section 4. Education Plus Program.
- 25 (a) Establishment.--There is hereby established the
- 26 Education Plus Program which shall be administered by the
- 27 department and which shall be designed to generate skills and
- 28 motivation necessary for success in education beyond secondary
- 29 school.
- 30 (b) Permissible services.--Any Education Plus Program

- 1 project assisted under this act may provide services such as:
- 2 (1) Instruction in reading, writing, study skills,
- 3 mathematics and other subjects necessary for success beyond
- 4 secondary school.
- 5 (2) Personal and career counseling.
- 6 (3) Academic advice and assistance in secondary school
- 7 course selection.
- 8 (4) Tutorial services.
- 9 (5) Exposure to cultural events, academic programs and
- 10 other activities not usually available to disadvantaged
- 11 youth.
- 12 (6) Activities designed to acquaint youths participating
- in the project with the range of career options available to
- 14 them.
- 15 (7) Instruction designed to prepare youths participating
- in the project for careers in which persons from
- disadvantaged backgrounds are particularly underrepresented.
- 18 (8) On-campus residential programs.
- 19 (9) Mentor programs involving elementary or secondary
- 20 school teachers, faculty members at institutions of higher
- 21 education, students or any combination of such persons.
- 22 (10) Assistance in completing college admission and
- 23 financial aid applications.
- 24 (11) Assistance in preparing for college entrance
- 25 examinations.
- 26 (12) Programs and activities as described in paragraphs
- 27 (1) through (11) which are specially designed for students of
- 28 limited English proficiency.
- 29 (c) Required services. -- Any Education Plus Program project
- 30 assisted under this act which has received funding for two or

- 1 more years shall include, as part of the core curriculum in the
- 2 next and succeeding years, instruction in mathematics through
- 3 precalculus, laboratory science, foreign language, composition
- 4 and literature.
- 5 (d) Eligible participants. -- Only secondary school students
- 6 in grade levels nine through 12 are eligible to participate.
- 7 Section 5. Agreement.
- 8 (a) General rule.--To be eligible for a grant under this
- 9 act, an institution of higher education shall enter into a
- 10 written partnership agreement with a local educational agency.
- 11 The partnership may include businesses, labor organizations,
- 12 professional associations, community-based organizations, public
- 13 television stations or other telecommunications entities, or
- 14 other public or private agencies or organizations. Each entity
- 15 participating in the partnership shall sign the agreement.
- 16 (b) Contents of agreement. -- The agreement shall include the
- 17 following:
- 18 (1) A listing of all participants in the partnership,
- 19 including a designation of the official representatives of
- 20 each entity participating in the partnership.
- 21 (2) A description of the responsibilities of each
- 22 participant in the partnership.
- 23 (3) A listing of the resources to be contributed by each
- 24 participant in the partnership.
- 25 Section 6. Grant program.
- 26 (a) Establishment.--There is hereby established a grant
- 27 program to implement the purposes of this act which is to be
- 28 administered by the secretary.
- 29 (b) Amount and use of grants. -- The secretary shall make
- 30 grants under this act in amounts which are not less than

- 1 \$100,000 and not more than \$500,000. A grant under this act may
- 2 be used by the partnership for programs that are designed to do
- 3 the following:
- 4 (1) Use college students to tutor secondary school
- 5 students and improve their basic academic skills or to
- 6 involve secondary school students in community service
- 7 learning projects.
- 8 (2) Improve the basic academic skills of secondary
- 9 school students.
- 10 (3) Increase the understanding of specific subjects of
- 11 secondary school students.
- 12 (4) Improve the opportunity to continue a program of
- education after graduation for secondary school students.
- 14 (5) Increase the prospects for employment after
- 15 graduation of secondary school students.
- 16 (c) Preferences. -- In making grants under this act, the
- 17 secretary shall give a preference to any of the following:
- 18 (1) Programs which will serve predominantly low-income
- 19 school districts.
- 20 (2) Partnerships which will run programs during the
- 21 regular school year and summer.
- 22 (3) Programs which will serve the following types of
- 23 students:
- 24 (i) Educationally disadvantaged students.
- 25 (ii) Students with disabilities.
- 26 (iii) Potential dropouts.
- 27 (iv) Pregnant adolescents and teenage parents.
- 28 (v) Children of migratory agricultural workers.
- 29 (vi) Students whose native language is other than
- 30 English.

- 1 (4) Programs designed to encourage women and minorities
- who are underrepresented in the fields of science and
- 3 mathematics to pursue these fields.
- 4 (d) Duration.--Each grant awarded under this act may be
- 5 awarded for a period not to exceed five years.
- 6 Section 7. Grant application.
- 7 (a) Application required.--A partnership desiring to receive
- 8 a grant under this act shall submit an application to the
- 9 secretary, in the form and providing any information the
- 10 secretary, by regulation or rule, shall require.
- 11 (b) Contents of application. -- The application shall include
- 12 the following:
- 13 (1) The partnership agreement described in section 5.
- 14 (2) A listing of the public and private nonprofit
- secondary school or schools to be involved in the program.
- 16 (3) A description of the activities and services for
- which assistance is sought.
- 18 (4) A description of the programs to be developed and
- 19 operated by the partnership.
- 20 (5) Assurances to the secretary that the following
- 21 guidelines will be met:
- (i) The partnership will establish a governing body
- 23 including one representative of each participant in the
- 24 partnership.
- 25 (ii) A local educational agency or institution of
- 26 higher education receiving funds under this act shall not
- 27 reduce its combined fiscal effort per student or its
- aggregate expenditure on education.
- 29 (iii) State funds will provide no more than 90% of
- 30 the cost of the project in the first year, 80% of the

- 1 cost in the second year and 70% of the cost in the third
- 2 year and any subsequent year.
- 3 (iv) In no case shall funds under a grant be used to
- 4 supplant non-State funds already available.
- 5 (c) Special rule. -- The non-State share of grants awarded
- 6 under this act may be in cash or in kind fairly evaluated,
- 7 including services, supplies or equipment.
- 8 (d) Waiver.--The secretary may waive the matching
- 9 requirement described in subsection (b)(5)(iii) for any eligible
- 10 partnership that demonstrates to the satisfaction of the
- 11 secretary a unique hardship that prevents compliance with the
- 12 matching requirement.
- 13 (e) Number of applications for grants and contracts. -- The
- 14 secretary shall not limit the number of applications submitted
- 15 by an entity under any program authorized under this act if the
- 16 additional applications describe programs serving different
- 17 populations or campuses.
- 18 Section 8. Application status.
- 19 The secretary shall inform each entity operating programs
- 20 under this act regarding the status of their application for
- 21 continued funding at least eight months prior to the expiration
- 22 of the grant or contract. The secretary, in the case of an
- 23 entity that is continuing to operate a successful program under
- 24 this act, shall ensure that the start-up date for a new grant or
- 25 contract for the program immediately follows the termination of
- 26 a preceding grant or contract so that no interruption of funding
- 27 occurs for successful re-applicants. The secretary shall inform
- 28 each entity requesting assistance under this section for a new
- 29 program regarding the status of its application at least eight
- 30 months prior to the proposed start-up date of the program.

- 1 Section 9. Outreach.
- 2 (a) Generally. -- The secretary shall conduct outreach
- 3 activities to ensure that entities eligible for assistance under
- 4 this act submit applications proposing programs that serve low-
- 5 income school districts and eligible populations which have been
- 6 underserved by the programs assisted under this act.
- 7 (b) Notice.--In carrying out the provisions of subsection
- 8 (a), the secretary shall notify the qualified entities of the
- 9 availability of assistance under this subsection not less than
- 10 120 days prior to the deadline for submission of applications
- 11 under this act.
- 12 (c) Technical assistance. -- The secretary shall provide
- 13 technical training to applicants for projects and programs
- 14 authorized under this act. The secretary shall give priority to
- 15 serving programs and projects that serve low-income school
- 16 districts and eligible populations which have been underserved
- 17 by the programs assisted under this act. Technical training
- 18 activities shall include the provision of information on
- 19 authorizing legislation, goals and objectives of the program,
- 20 required activities, eligibility requirements, application
- 21 process and deadlines, and assistance in the development of
- 22 program proposals and the completion of program applications.
- 23 All training shall be furnished at convenient geographic
- 24 locations to ensure that all areas of this Commonwealth with
- 25 large concentrations of eligible participants are served.
- 26 (d) Special rule. -- The secretary may contract with eligible
- 27 entities to conduct the outreach activities described in this
- 28 section.
- 29 Section 10. Program review.
- 30 (a) General.--For the purpose of improving the operation of

- 1 the programs and projects assisted under this act, the secretary
- 2 is authorized to make grants to and enter into contracts with
- 3 institutions of higher education and other public and private
- 4 institutions and organizations to evaluate the effectiveness of
- 5 the various programs assisted under this act in meeting the
- 6 purposes of this act.
- 7 (b) Content. -- The evaluations described in subsection (a)
- 8 shall identify institutional, community and program practices
- 9 particularly effective in increasing the access of low-income
- 10 individuals and first-generation college students to
- 11 postsecondary education, and ensuring success in postsecondary
- 12 education.
- 13 (c) Results.--In order to improve program effectiveness, the
- 14 results of the ongoing evaluations described in subsection (a)
- 15 shall be disseminated by the secretary to the programs assisted
- 16 under this act, to individuals concerned with the postsecondary
- 17 access and retention of low-income individuals and first-
- 18 generation college students and to the General Assembly.
- 19 Section 11. Appropriation.
- The sum of \$1,500,000, or as much thereof as may be
- 21 necessary, is hereby appropriated to the Department of Education
- 22 for the fiscal year July 1, 1994, to June 30, 1995, to carry out
- 23 the provisions of this act.
- 24 Section 12. Effective date.
- This act shall take effect in 60 days.
