AN ACT

- 1 Creating the Committee for the Coordination of Police Services
- 2 to Elderly Persons; and providing for powers and duties of
- 3 the committee.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Coordination
- 8 of Police Services to Elderly Persons Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Committee." The Committee for the Coordination of Police
- 14 Services to Elderly Persons established under section 3.
- 15 "Department." The Department of Aging of the Commonwealth.
- 16 "Triad program." The triad cooperative model developed by
- 17 the American Association of Retired Persons, the National
- 18 Sheriffs' Association and the International Association of

- 1 Chiefs of Police which calls for the participation of the
- 2 sheriff, at least one police chief and a representative of at
- 3 least one senior citizens' organization within a county and may
- 4 include participation by general service coalitions of law
- 5 enforcement, victim service and senior citizen advocate
- 6 organizations. If there is not both a sheriff and a police chief
- 7 in a county or if the sheriff or a police chief does not
- 8 participate, a triad may include in the place of the sheriff or
- 9 police chief another key law enforcement official in the county
- 10 such as a district attorney.
- 11 Section 3. Establishment of committee.
- 12 There is hereby established within the Department of Aging
- 13 the Committee for the Coordination of Police Services to Elderly
- 14 Persons.
- 15 Section 4. Membership and operation of committee.
- 16 (a) Members.--The Committee for the Coordination of Police
- 17 Services to Elderly Persons shall consist of ten members, as
- 18 follows:
- 19 (1) The Secretary of Aging, who shall serve as presiding
- 20 officer of the committee.
- 21 (2) The Commissioner of the Pennsylvania State Police.
- 22 (3) The Attorney General.
- 23 (4) The presiding officer of the Crime Victim's
- 24 Compensation Board.
- 25 (5) Two county sheriffs, to be appointed by the
- 26 Governor.
- 27 (6) Two municipal police chiefs, to be appointed by the
- 28 Governor.
- 29 (7) Two citizens at large both of whom shall be 65 years
- of age or older, to be appointed by the Governor.

- 1 (b) Method of appointment. -- Appointments by the Governor
- 2 shall be made from nominations submitted by relevant
- 3 organizations.
- 4 (c) Term.--Members of the committee appointed by the
- 5 Governor shall serve for a term of three years. A member may be
- 6 reappointed for additional terms.
- 7 (d) Cessation of participation. -- A member of the committee
- 8 shall, immediately upon removal or retirement from the position
- 9 by virtue of which the member was eligible for appointment,
- 10 cease to be a member of the committee.
- 11 (e) Vacancies. -- A member appointed to fill a vacancy created
- 12 other than by expiration of a term shall be appointed for the
- 13 unexpired term of the member whom he is to succeed in the same
- 14 manner as the original appointment.
- 15 (f) Reimbursement.--Members of the committee shall serve
- 16 without compensation, but may be reimbursed for necessary and
- 17 actual expenses incurred in attending meetings of the committee
- 18 and in the performance of their duties under this act.
- 19 (g) Removal.--Members of the committee may be removed by the
- 20 Governor for cause after written notice from the Governor.
- 21 (h) Meetings.--The committee shall meet as often as its
- 22 members deem necessary, but not less than twice per year.
- 23 Section 5. Powers and duties of committee.
- 24 The Committee for the Coordination of Police Services to
- 25 Elderly Persons shall advise the Department of Aging, the
- 26 Pennsylvania State Police, county sheriffs and other local law
- 27 enforcement agencies, senior advocates and other relevant
- 28 parties chosen in consultation with the department in the study
- 29 and evaluation of triad programs as an effective response to the
- 30 problems of crime against elderly persons. The committee may

- 1 also consult with experts, service providers and representative
- 2 organizations engaged in the protection of the elderly and may
- 3 recommend the development of triad programs in this Commonwealth
- 4 to assist the elderly to avoid criminal victimization through
- 5 coordinated efforts of State and local law enforcement agencies
- 6 and organizations which provide services for the elderly. The
- 7 committee may also recommend policies and programs to assist law
- 8 enforcement agencies in implementing triad programs, including
- 9 training and prevention standards and technical assistance. The
- 10 powers and duties of the committee shall include the following:
- 11 (1) Establishment of a Statewide and central
- 12 clearinghouse for information and education materials.
- 13 (2) Development of innovative community police programs
- 14 for the elderly.
- 15 (3) Providing assistance to the Municipal Police
- 16 Officers' Education and Training Commission in the
- development and delivery of training to law enforcement
- 18 professionals involved in the triad programs, including, but
- 19 not limited to, the subjects of:
- 20 (i) crimes against the elderly and the protection of
- 21 elderly persons;
- 22 (ii) police sensitivity to the needs of elderly
- persons as victims and witnesses; and
- 24 (iii) social and human services.
- 25 (4) Providing assistance to State and local law
- 26 enforcement officials and to not-for-profit corporations and
- 27 organizations with respect to effective policies for and
- responses to crimes against elderly persons.
- 29 (5) Promoting and facilitating cooperation among State
- 30 agencies and local units of government.

- 1 (6) Effective advocacy of services to protect elderly 2 persons and elderly victims of crime.
- 3 (7) Evaluating the relationship between crimes against
- 4 elderly persons and other problems confronting elderly
- 5 persons, and making recommendations for effective policy
- 6 response.
- 7 (8) Collection of statistical data and research.
- 8 (9) Promulgation of rules and regulations as may be
- 9 necessary to carry out the purposes of this act.
- 10 Section 6. Effective date.
- 11 This act shall take effect in 60 days.
