AN ACT

- 1 Making an appropriation to the Trustees of Drexel University, 2 Philadelphia.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The sum of \$5,446,000 is hereby appropriated to
- 6 the Trustees of Drexel University, Philadelphia, for the fiscal
- 7 year July 1, 1994, to June 30, 1995, for instruction and student
- 8 aid.
- 9 Section 2. Payments to Drexel University on account of the
- 10 appropriation provided in section 1 shall be made by the
- 11 Secretary of Education in equal quarterly payments. THE
- 12 SECRETARY OF EDUCATION SHALL NOT RELEASE MORE THAN THE FIRST
- 13 OUARTERLY PAYMENT UNTIL SUCH TIME AS THE TRUSTEES OF DREXEL
- 14 UNIVERSITY INCLUDE FIVE MEMBERS APPOINTED BY THE GOVERNOR AND
- 15 THE GENERAL ASSEMBLY. THE GOVERNOR, THE PRESIDENT PRO TEMPORE OF
- 16 THE SENATE, THE MINORITY LEADER OF THE SENATE, THE SPEAKER OF
- 17 THE HOUSE OF REPRESENTATIVES AND THE MINORITY LEADER OF THE

- 1 HOUSE OF REPRESENTATIVES SHALL EACH, UPON INVITATION BY THE
- 2 TRUSTEES, APPOINT A NONELECTED OFFICIAL TO SERVE AS A MEMBER OF
- 3 THE BOARD AND THE TERMS OF OFFICE SHALL BE COTERMINOUS WITH THAT
- 4 OF THEIR APPOINTING AUTHORITY.
- 5 Section 3. The Drexel University shall provide full,
- 6 complete and accurate information as may be required by the
- 7 Department of Education or the chairman or the minority chairman
- 8 of the Appropriations Committee of the Senate or the chairman or
- 9 the minority chairman of the Appropriations Committee of the
- 10 House of Representatives.
- 11 Section 4. Drexel University shall report its revenues and
- 12 expenditures and present its financial statements in accordance
- 13 with generally accepted accounting principles and procedures for
- 14 educational institutions as set forth in the "Higher Education
- 15 Finance Manual (1975)" and the "Commonwealth of Pennsylvania
- 16 Budget Instructions for the State System of Higher Education,
- 17 State-Related Universities and Non-State-Related Colleges and
- 18 Universities."
- 19 Section 5. The Trustees of Drexel University shall report on
- 20 forms provided by the Department of Education to the chairman
- 21 and the minority chairman of the Appropriations Committee of the
- 22 Senate and the chairman and minority chairman of the
- 23 Appropriations Committee of the House of Representatives by
- 24 September 30, 1995, on how State-appropriated funds were
- 25 expended for fiscal year 1994-1995 to reduce the costs to
- 26 Pennsylvania resident students or to provide services to
- 27 Pennsylvania residents.
- 28 Section 6. This act shall take effect July 1, 1994, or
- 29 immediately, whichever is later.
