AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for penalties and
- 3 sentencing for firearms' violations.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6105 of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 6105. Former convict not to own a firearm, etc.
- 9 (a) General rule. -- No person who has been convicted in this
- 10 Commonwealth or elsewhere of a crime of violence shall own a
- 11 firearm, or have one in his possession or under his control.
- 12 (b) Penalty.--A person who violates the provisions of this
- 13 section commits a felony of the second degree and shall, upon
- 14 conviction, be sentenced to a mandatory minimum term of
- 15 <u>imprisonment for five years. There shall be no authority in any</u>
- 16 court to impose on an offender to which this section is
- 17 applicable a lesser sentence than provided for in this section

- 1 or to place the offender on probation, parole, work release or
- 2 prerelease or to suspend sentence. Nothing in this section shall
- 3 prevent the sentencing court from imposing a sentence greater
- 4 than provided in this section. Sentencing guidelines promulgated
- 5 by the Pennsylvania Commission on Sentencing shall not supersede
- 6 the mandatory sentences provided in this section.
- 7 (c) Appellate review.--If a sentencing court refuses to
- 8 apply this section where applicable, the Commonwealth shall have
- 9 the right to appellate review of the action of the sentencing
- 10 court. The appellate court shall vacate the sentence and remand
- 11 the case to the sentencing court for imposition of a sentence in
- 12 accordance with this section if it finds that the sentence was
- 13 <u>imposed in violation of this section.</u>
- 14 Section 2. Section 6106 of Title 18 is amended by adding a
- 15 subsection to read:
- 16 § 6106. Firearms not to be carried without a license.
- 17 * * *
- 18 (e) Penalty.--A person who violates the provisions of this
- 19 section commits a felony of the third degree.
- 20 Section 3. This act shall take effect in 60 days.
