## A RESOLUTION

1 2 3	Memorializing members of the House of Representatives to recognize April 1994 as "Sexual Assault Awareness Month" to end sexual violence and celebrate survival.
4	WHEREAS, According to the Pennsylvania Coalition Against Rape
5	(PCAR), during fiscal year 1992-1993, the 46 sexual assault
6	centers in the PCAR network served 33,862 clients, 11,940 of
7	whom were adult victims, 8,468 of whom were child victims and
8	13,454 of whom were significant others; and
9	WHEREAS, During 1992-1993, more than 1,000 newly trained
10	volunteers joined thousands of experienced volunteers providing
11	invaluable services, including the operation of telephone
12	hotlines, court and hospital accompaniment and public relations;
13	and
14	WHEREAS, Many victims still hesitate to report incidents of
15	sexual violence to the proper authorities because of fear,
16	embarrassment, guilt and distrust due to internal and external

1 social factors; and

2 WHEREAS, Rape crisis centers and domestic violence shelters 3 across this Commonwealth are organizing marches, rallies and other events to increase public awareness of the issue of sexual 4 5 violence, including the display in the Capitol Rotunda this week of wall hangings created by survivors of sexual violence, the 6 making of which was coordinated by the staff of Indiana County's 7 rape crisis and domestic violence shelter, the Alice Paul House; 8 therefore be it 9

10 RESOLVED, That the House of Representatives recognize that 11 every citizen of this Commonwealth has the right to live free 12 from the fear of sexual violence whether on the streets or in 13 his or her own home; and be it further

14 RESOLVED, That the House of Representatives recognize the 15 need to promote an awareness of sexual violence and the 16 development of appropriate programs to combat such violence, 17 which tears at the social and moral fabric of our Nation and 18 State; and be it further

19 RESOLVED, That the House of Representatives recognize the 20 need for the Commonwealth to provide hospitals, rape crisis 21 centers and other institutions with the necessary resources and 22 support to assist survivors of sexual violence to recover from 23 their tragic experiences; and be it further

RESOLVED, That the House of Representatives recognize the need to educate children and all citizens of this Commonwealth concerning techniques to prevent sexual violence, as well as providing channels of assistance to help those who do experience sexual violence; and be it further

1 law enforcement agencies and other public service institutions 2 to help create a social environment in which victims of sexual 3 violence do not suffer from embarrassment, shame, guilt or 4 intimidation when reporting incidents of such violence; and be 5 it further

6 RESOLVED, That the House of Representatives recognize the 7 commemoration of April 1994 as "Sexual Assault Awareness Month" 8 in an effort to rid society of sexual violence; and be it 9 further

10 RESOLVED, That the House of Representatives encourage all its 11 members to participate within their local communities in the 12 events that will occur in April 1994 to commemorate "Sexual 13 Assault Awareness Month" as well as to work closely throughout 14 the year with rape crisis centers in their districts in 15 recognition of the need to end sexual violence and celebrate 16 life.
