- 1 Designating the week of April 24 through April 30, 1994, as 2 "Victim Rights Week" in Pennsylvania.
- 3 WHEREAS, All Pennsylvanians, regardless of gender, race, age

- 6 WHEREAS, Victims of sexual violence, domestic violence and
- 7 other violent crimes should have full access to services and
- 8 programs which provide short-term and long-term assistance for
- 9 victimization recovery; and
- 10 WHEREAS, The Pennsylvania Coalition Against Rape, the
- 11 Pennsylvania Coalition Against Domestic Violence and the
- 12 Pennsylvania Commission on Crime and Delinquency and their

- 2 commitment to providing services to and protecting the rights of
- 3 victims of sexual violence and domestic violence and other
