The sum of \$3,730,000 is hereby appropriated from 27 the restricted revenue account within the General Fund to the Office of Consumer Advocate in the Office of the Attorney 28 General to provide for the operation of that office for the 29 30 fiscal year July 1, 1993, to June 30, 1994.

1 Section 3. The sum of \$739,000 is hereby appropriated from 2 the restricted revenue account within the General Fund to the 3 Office of Small Business Advocate in the Department of Commerce 4 to provide for the operation of that office for the fiscal year 5 July 1, 1993, to June 30, 1994.

6 Section 4. This act shall take effect July 1, 1993, or7 immediately, whichever is later.
