3	The General Assembly of the Commonwealth of Pennsylvania

5	SECTION 1. (A) THE SUM OF \$1,705,000 IS HEREBY APPROPRIATED	<-
6	TO THE MEDICAL COLLEGE OF PENNSYLVANIA LOCATED IN EAST FALLS,	
7	PHILADELPHIA, FOR THE FISCAL YEAR JULY 1, 1992, TO JUNE 30,	
8	1993, FOR INSTRUCTION IN THE DOCTOR OF MEDICINE PROGRAM.	
9	(B) THE SUM OF \$473,000 IS HEREBY APPROPRIATED TO THE	
10	MEDICAL COLLEGE OF PENNSYLVANIA, PHILADELPHIA, FOR THE FISCAL	
11	YEAR JULY 1, 1992, TO JUNE 30, 1993, FOR THE GENERAL MAINTENANCE	
12	OF THE MEDICAL COLLEGE OF PENNSYLVANIA, INCLUDING THE SCHOOL OF	
13	ALLIED HEALTH, AND STUDENT AID.	
14	Section <del>1.</del> 2. (A) The sum of <del>\$3,409,000</del> \$2,457,000 is	<-
15	hereby appropriated to The Medical College of Pennsylvania	
16	located in East Falls, Philadelphia, for the fiscal year July 1,	

1993, to June 30, 1994, for instruction in the Doctor of
 Medicine program.

3 Section 2. (B) The sum of \$945,000 \$709,000 is hereby
4 appropriated to The Medical College of Pennsylvania,
5 Philadelphia, for the fiscal year July 1, 1993, to June 30,
6 1994, for the general maintenance of The Medical College of
7 Pennsylvania, including the School of Allied Health, and student
8 aid.

9 Section 3. Payments to The Medical College of Pennsylvania
10 on account of the appropriations provided in sections 1 and 2
11 shall be made quarterly by the Secretary of Education on the
12 basis of costs during the fiscal year.:

13 (1) SECTION 1 SHALL BE MADE IN A LUMP SUM BY THE14 SECRETARY OF EDUCATION.

15 (2)SECTION 2 SHALL BE MADE QUARTERLY BY THE SECRETARY 16 OF EDUCATION ON THE BASIS OF COSTS DURING THE FISCAL YEAR. 17 Section 4. The Medical College of Pennsylvania shall provide 18 full, complete and accurate information as may be required by 19 the Department of Education or the majority chairman or the 20 minority chairman of the Appropriations Committee of the Senate 21 or the majority chairman or the minority chairman of the 22 Appropriations Committee of the House of Representatives. 23 Section 5. The Medical College of Pennsylvania shall report 24 its revenues and expenditures and present its financial 25 statements in accordance with generally accepted accounting 26 principles and procedures for educational institutions as set 27 forth in the "Higher Education Finance Manual (1975)" and the 28 "Commonwealth of Pennsylvania Budget Instructions for the State 29 System of Higher Education, State-Related Universities and Non-30 State-Related Colleges and Universities."

1 Section 6. This act shall take effect July 1, 1993, or

2 immediately, whichever is later.

3 SECTION 6. THE MEDICAL COLLEGE OF PENNSYLVANIA SHALL REPORT <----4 ON FORMS PROVIDED BY THE DEPARTMENT OF EDUCATION TO BOTH THE 5 MAJORITY AND MINORITY CHAIRS OF THE SENATE AND HOUSE 6 APPROPRIATIONS COMMITTEES BY SEPTEMBER 30, 1994, ON HOW STATE-7 APPROPRIATED FUNDS WERE EXPENDED FOR FISCAL YEAR 1993-1994 TO 8 REDUCE THE COSTS TO PENNSYLVANIA-RESIDENT STUDENTS OR TO PROVIDE 9 SERVICES TO PENNSYLVANIA RESIDENTS.

10 SECTION 7. THIS ACT SHALL TAKE EFFECT AS FOLLOWS:

(1) SECTIONS 1 AND 3 OF THIS ACT AND THIS SECTION SHALL 11 12 TAKE EFFECT IMMEDIATELY.

13 (2) THE REMAINDER OF THIS ACT SHALL TAKE EFFECT JULY 1, 14 1993, OR IMMEDIATELY, WHICHEVER IS LATER.
