AN ACT

- 1 Mandating health insurance coverage of annual gynecological examinations and routine pap smears; and making repeals.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Women's
- 7 Preventative Health Services Act.
- 8 Section 2. Declaration of policy.
- 9 The General Assembly finds and declares as follows:
- 10 (1) As the issue of universal health care is debated at
- 11 the Federal and State levels, the special health care needs
- of women must be addressed.
- 13 (2) If women had access to quality preventative health
- 14 care, many diseases could be prevented or treated in their
- early stages when it is less expensive and there is a much
- 16 better chance of recovery.
- 17 (3) Less than 60% of women 40 years of age or older and

- 1 70 years of age or younger have pap smears at least once
- 2 every three years.
- 3 (4) Nearly 7,000 women die each year from cervical
- 4 cancer nationwide.
- 5 (5) In 1989 there were 212 cervical cancer deaths in
- 6 this Commonwealth.
- 7 (6) Nine out of ten deaths from cervical cancer could be
- 8 prevented if more women had regular pap smears.
- 9 (7) In 1989, 658 cases of cervical cancer were diagnosed
- and reported in this Commonwealth. The number of cases
- 11 reported have increased consistently since 1985.
- 12 Section 3. Definitions.
- 13 The following words and phrases when used in this act shall
- 14 have the meanings given to them in this section unless the
- 15 context clearly indicates otherwise:
- 16 "Health insurance policy." Any individual or group health,
- 17 sickness or accident policy or subscriber contract or
- 18 certificate issued by an entity subject to any one of the
- 19 following:
- 20 (1) The act of May 17, 1921 (P.L.682, No.284), known as
- 21 The Insurance Company Law of 1921.
- 22 (2) The act of December 29, 1972 (P.L.1701, No.364),
- 23 known as the Health Maintenance Organization Act.
- 24 (3) 40 Pa.C.S. Ch. 61 (relating to hospital plan
- corporations), 63 (relating to professional health services
- 26 plan corporations) or 65 (relating to fraternal benefit
- 27 societies).
- 28 (4) The act of May 18, 1976 (P.L.123, No.54), known as
- 29 the Individual Accident and Sickness Insurance Minimum
- 30 Standards Act.

- 1 (5) Medical assistance.
- 2 Section 4. Mandated coverage.
- 3 A health insurance policy which is delivered, issued for
- 4 delivery, renewed, extended or modified in this Commonwealth by
- 5 a health care insurer shall provide that the health insurance
- 6 benefits applicable under the policy include coverage for
- 7 periodic health maintenance to include:
- 8 (1) Annual gynecological examination, including a pelvic
- 9 examination and clinical breast examination.
- 10 (2) Routine pap smears in accordance with the
- 11 recommendations of the American College of Obstetricians and
- 12 Gynecologists.
- 13 Section 5. Delivery of policy.
- 14 If a health insurance policy provides coverage or benefits to
- 15 a resident of this Commonwealth, it shall be deemed to be
- 16 delivered in this Commonwealth within the meaning of this act,
- 17 regardless of whether the health care insurer issuing or
- 18 delivering the policy is located within or outside of this
- 19 Commonwealth.
- 20 Section 6. Repeals.
- 21 All acts and parts of acts are repealed insofar as they are
- 22 inconsistent with this act.
- 23 Section 7. Applicability.
- 24 This act shall apply to all insurance policies, subscriber
- 25 contracts and group insurance certificates issued under any
- 26 group master policy delivered or issued for delivery on or after
- 27 the effective date of this act. This act shall also apply to all
- 28 renewals of contracts on any renewal date which is on or after
- 29 the effective date of this act.
- 30 Section 8. Effective date.

1 This act shall take effect in 60 days.
