## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
  Statutes, further defining "pedalcycles"; further providing
  for the operation of pedalcycles on Commonwealth highways,
  for pedalcycle helmets, for the use of hearing impairment
  devices and for hand and arm signals; repealing the
  Pedalcycle Helmet Fund; and providing for the establishment
  of the Pennsylvania Pedalcycle and Pedestrian Advisory
  Committee.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. The definition of "pedalcycle" in section 102 of
- 12 Title 75 of the Pennsylvania Consolidated Statutes is amended to
- 13 read:
- 14 § 102. Definitions.
- 15 Subject to additional definitions contained in subsequent
- 16 provisions of this title which are applicable to specific
- 17 provisions of this title, the following words and phrases when
- 18 used in this title shall have, unless the context clearly
- 19 indicates otherwise, the meanings given to them in this section:

- 1 \* \* \*
- 2 "Pedalcycle." A vehicle propelled solely by human-powered
- 3 pedals. The term does not mean a three-wheeled human-powered
- 4 pedal-driven vehicle with a main driving wheel 20 inches in
- 5 diameter or under and primarily designed for children six years
- 6 of age or younger.
- 7 \* \* \*
- 8 Section 2. Section 3105 of Title 75 is amended by adding a
- 9 subsection to read:
- 10 § 3105. Drivers of emergency vehicles.
- 11 \* \* \*
- 12 (f) Pedalcycles.--No part of this title shall be construed
- 13 to restrict the operation of a pedalcycle used by a police
- 14 officer during the course of performing official duties.
- 15 Section 3. Sections 3314, 3336, 3504, 3505 and 3507(a) of
- 16 Title 75 are amended to read:
- 17 § 3314. Prohibiting use of hearing impairment devices.
- 18 (a) General rule. -- No [driver] person shall operate a
- 19 vehicle while wearing or using one or more headphones[,] or
- 20 earphones. [or any similar device which the department by
- 21 regulation determines would impair the ability of the driver to
- 22 hear traffic sounds.1
- 23 (b) Exception.--This section does not prohibit the use of
- 24 hearing aids or other devices for improving the hearing of the
- 25 [driver] person nor does it prohibit the use of communication
- 26 equipment by the driver of [a fire vehicle] an emergency vehicle
- 27 or by motorcycle operators complying with section 3525 (relating
- 28 to protective equipment for motorcycle riders).
- 29 § 3336. Method of giving hand and arm signals.
- All signals given by hand and arm shall be given from the

- 1 left side of the vehicle in the following manner except as
- 2 <u>indicated for pedalcycles and motorcycles</u> and the signals shall
- 3 indicate as follows:
- 4 (1) For a left turn, the hand and arm shall be extended
- 5 horizontally.
- 6 (2) For a right turn, the <u>left</u> hand and arm shall be
- 7 extended upward[.], except that operators of motorcycles and
- 8 pedalcycles may also be permitted to signal a right turn by
- 9 <u>extending the right hand and arm horizontally.</u>
- 10 (3) To stop or decrease speed, the <u>left</u> hand and arm
- shall be extended downward.
- 12 § 3504. Riding on pedalcycles.
- 13 (a) Use of seat by operator. -- A person propelling a
- 14 pedalcycle shall not ride other than upon or astride a permanent
- 15 and regular seat attached to the pedalcycle.
- 16 (b) Number of riders.--No pedalcycle shall be used to carry
- 17 more persons at one time than the number for which the
- 18 pedalcycle is designed and equipped except that an adult rider
- 19 may [carry a child securely attached to the rider in a back pack
- 20 or sling] transport a child in a restraining seat which is
- 21 <u>securely attached to the pedalcycle or in a trailer which is</u>
- 22 towed by a pedalcycle.
- 23 § 3505. Riding on roadways and pedalcycle paths.
- 24 [(a) General rule.--Except as provided in subsection (b),
- 25 every person operating a pedalcycle upon a roadway shall ride as
- 26 near to the right side of the roadway as practicable, exercising
- 27 due care when passing a standing vehicle or one proceeding in
- 28 the same direction.
- 29 (b) One-way highways.--Any person operating a pedalcycle
- 30 upon a roadway of a highway, which highway carries traffic in

- 1 one direction only and has two or more marked traffic lanes, may
- 2 ride as near the left-hand curb or edge of the roadway as
- 3 practicable, exercising due care when passing a standing vehicle
- 4 or one proceeding in the same direction.
- 5 (c) Limitation on riding abreast.--Persons riding
- 6 pedalcycles upon a roadway shall not ride more than two abreast
- 7 except on paths or parts of roadways set aside for the exclusive
- 8 use of pedalcycles.
- 9 (d) Use of available pedalcycle paths. -- Whenever a lane or
- 10 path for pedalcycles has been provided as part of a highway,
- 11 pedalcycle riders shall use the lane or path and shall not use
- 12 any other part of the highway. This subsection does not apply
- 13 when use of the pedalcycle lane or path is not possible, safe or
- 14 reasonable.]
- 15 (a) General rule. -- Except as provided in subsections (b) and
- 16 (c), every person operating a pedalcycle upon a highway shall
- 17 obey the applicable rules of the road as contained in this
- 18 title.
- 19 (b) Operation on shoulder.--A pedalcycle may be operated on
- 20 the shoulder of a highway and shall be operated in the same
- 21 direction as required of vehicles operated on the roadway.
- 22 (c) Slower than prevailing speeds. -- A pedalcycle operated at
- 23 <u>slower than prevailing speed shall be operated in accordance</u>
- 24 with the provisions of section 3301(b), unless it is unsafe to
- 25 <u>do so.</u>
- 26 (d) One-way roadways.--Any person operating a pedalcycle
- 27 upon a roadway, which carries traffic in one direction only and
- 28 has two or more marked traffic lanes, may ride as near the left-
- 29 <u>hand curb or edge of the roadway as practicable, exercising due</u>
- 30 care when passing a standing vehicle or one proceeding in the

- 1 same direction.
- 2 (e) Two-way roadways. -- On two-way roadways, any pedalcycle
- 3 shall be driven in the right-hand lane then available for
- 4 traffic and as close as practicable to the right-hand curb or
- 5 edge of the roadway. This subsection shall not apply to an
- 6 operator who must necessarily drive away from the right-hand
- 7 curb or edge of the roadway for reasons of safety.
- 8 (f) Limitation on riding abreast.--Persons riding
- 9 <u>pedalcycles upon a roadway shall not ride more than two abreast</u>
- 10 except on paths or parts of roadways set aside for the exclusive
- 11 <u>use of pedalcycles</u>.
- 12 § 3507. Lamps and other equipment on pedalcycles.
- 13 (a) Lamps and reflectors. -- Every pedalcycle when in use
- 14 between sunset and sunrise shall be equipped on the front with a
- 15 lamp which emits a <u>beam of</u> white light <u>intended to illuminate</u>
- 16 the pedalcycle operator's path and visible from a distance of at
- 17 least 500 feet to the front. Operators of pedalcycles may
- 18 supplement the required front lamp with a white flashing lamp,
- 19 light-emitting diode or similar device to enhance their
- 20 <u>visibility to other traffic</u> and with a red reflector on the rear
- 21 [of a type approved by the department] which shall be visible
- 22 from all distances from [100 feet to 600] 500 feet to the rear
- 23 and with an amber reflector on each side. A lamp emitting a red
- 24 [light] flashing lamp, light-emitting diode or similar device
- 25 visible from a distance of 500 feet to the rear may be used in
- 26 addition to the red reflector. A lamp worn by the operator of a
- 27 pedalcycle shall comply with the requirements of this subsection
- 28 if the lamp can be seen at the distances specified. [All lamps
- 29 and reflectors shall be of a type approved by the department.]

- 1 Section 4. Section 3510 of Title 75, amended December 28,
- 2 1994 (P.L.1445, No.170), is amended to read:
- 3 § 3510. Pedalcycle helmets for certain persons.
- 4 (a) General rule. -- A person under 12 years of age shall not
- 5 operate a pedalcycle or ride as a passenger on a pedalcycle
- 6 unless the person is wearing a pedalcycle helmet meeting the
- 7 standards of the American National Standards Institute [or of],
- 8 the American Society for Testing and Materials, the Snell
- 9 Memorial Foundation's Standards for Protective Headgear for Use
- 10 in Bicycling or any other nationally recognized standard for
- 11 pedalcycle helmet approval. This subsection shall also apply to
- 12 a person who rides:
- 13 (1) upon a pedalcycle while in a restraining seat
- 14 attached to a pedalcycle; or
- 15 (2) in a trailer towed by a pedalcycle.
- 16 (b) Helmet to be labeled. -- Any helmet sold or offered for
- 17 sale for use by operators and passengers of pedalcycles shall be
- 18 [conspicuously] labeled in accordance with the standard
- 19 described in subsection (a), which shall constitute the
- 20 manufacturer's certification that the helmet conforms to the
- 21 applicable safety standards.
- 22 (b.1) Sale of helmet.--No person shall sell or offer for
- 23 sale for use by an operator or passenger of a pedalcycle a
- 24 helmet which is not of a type meeting the requirements
- 25 established by this section.
- 26 (b.2) Waiver of fine.--If a person receives a citation
- 27 issued by the proper authority for violation of subsection (a),
- 28 a district justice, magistrate or judge shall dismiss the
- 29 charges if the person prior to or at his hearing displays
- 30 evidence of acquisition of a helmet meeting the standards

- 1 prescribed in subsection (a) to such district justice,
- 2 magistrate or judge. Sufficient evidence shall include a receipt
- 3 mailed to the appropriate court officer which evidences purchase
- 4 or transfer of such a helmet from another helmet owner,
- 5 evidenced by a notarized letter.
- 6 (B.3) EXEMPTION.--THIS SECTION SHALL NOT APPLY TO A CHILD
- 7 UNDER 12 YEARS OF AGE WHO CAN PRODUCE A STATEMENT FROM THE
- 8 FAMILY'S CHURCH AUTHORITIES ATTESTING THAT IT IS AGAINST THE
- 9 TENETS OF THE FAMILY'S RELIGION TO WEAR A HELMET.
- 10 (c) Civil actions.--In no event shall a violation or alleged
- 11 violation of subsection (a) be used as evidence in a trial of
- 12 any civil action; nor shall any jury in a civil action be
- 13 instructed that any conduct did constitute or could be
- 14 interpreted by them to constitute a violation of subsection (a);
- 15 nor shall failure to use a pedalcycle helmet be considered as
- 16 contributory negligence nor shall failure to use a pedalcycle
- 17 helmet be admissible as evidence in the trial of any civil
- 18 action.
- 19 (d) Penalty. -- Notwithstanding any other provisions of law,
- 20 any violation of subsection (a) is punishable by a fine,
- 21 including all penalties, assessments and court costs imposed on
- 22 the convicted person not to exceed \$25. [The court imposing and
- 23 collecting any such fines shall transfer the fines thus
- 24 collected to the State Treasurer for deposit in the Pedalcycle
- 25 Helmet Fund, pursuant to section 3512 (relating to Pedalcycle
- 26 Helmet Fund).] The parent or legal guardian having control or
- 27 custody of a person under 12 years of age whose conduct violates
- 28 this section shall be jointly and severally liable with the
- 29 person for the amount of the fine imposed.
- 30 (e) Definitions.--As used in this section, the term "wearing

- 1 a pedalcycle helmet means having a pedalcycle helmet of good
- 2 fit fastened securely upon the head with the helmet straps.
- 3 Section 5. Section 3511 of Title 75 is amended by adding a
- 4 subsection to read:
- 5 § 3511. Pedalcycles prohibited on freeways.
- 6 \* \* \*
- 7 (d) Operation on shoulder.--If the department authorizes
- 8 pedalcycle access to a freeway, the pedalcycle shall be operated
- 9 upon the shoulder of that freeway whenever practicable.
- 10 Section 6. Section 3512 of Title 75 is repealed.
- 11 Section 7. Chapter 35 of Title 75 is amended by adding a
- 12 subchapter to read:

- 19 3571. Pedalcycle and Pedestrian Advisory Committee.
- 20 § 3571. Pedalcycle and Pedestrian Advisory Committee.
- 21 (a) Establishment. -- There is hereby established under the
- 22 jurisdiction of the Department of Transportation a board known
- 23 as the Pennsylvania Pedalcycle and Pedestrian Advisory
- 24 Committee.
- 25 (b) Composition. -- The committee shall consist of 23 members.
- 26 The members shall be as follows:
- 27 (1) The Secretary of Transportation, ex officio.
- 28 (2) The Secretary of Commerce, ex officio.
- 29 (3) The Secretary of Health, ex officio.
- 30 (4) The Secretary of Environmental Resources, ex

- 1 officio.
- 2 (5) The Commissioner of the Pennsylvania State Police,
- 3 ex officio.
- 4 (6) The Secretary of Education, ex officio.
- 5 (7) The Secretary of Community Affairs, ex officio.
- 6 (8) The chairman and minority chairman of the
- 7 Transportation Committee of the Senate.
- 8 (9) The chairman and minority chairman of the
- 9 Transportation Committee of the House of Representatives.
- 10 (10) Twelve members of the public representing areas of
- 11 concern specified who shall have extensive experience and
- 12 knowledge of bicycle, pedalcycle, pedestrian and human power
- issues throughout this Commonwealth, to be appointed by the
- 14 Governor as follows:
- 15 (i) Two members from a list of at least six
- 16 representatives submitted by the Bicycling Federation of
- 17 Pennsylvania.
- 18 (ii) One member from a list of at least three
- 19 representatives submitted by the League of American
- 20 Bicyclists.
- 21 (iii) One member from a list of at least three
- 22 representatives submitted by the United States Cycling
- 23 Federation.
- 24 (iv) One member from a list of at least three
- 25 representatives submitted by the Pennsylvania Chapter of
- the Rails-to-Trails Conservancy.
- 27 (v) One member from a list of at least three
- 28 representatives submitted by the Eastern Paralyzed
- 29 Veterans Association.
- 30 (vi) One member from a list of at least three

- representatives submitted by the American Association of Retired Persons.
- 3 (vii) One member from a list of at least three
- 4 representatives submitted by the Bicycle Coalition of
- 5 Delaware Valley.
- 6 (viii) One member from a list of at least three
- 7 representatives submitted by the Lehigh Valley Bicycle
- 8 Riders Alliance.
- 9 (ix) One member from a list of at least three
- 10 representatives submitted by the Pittsburgh Area Cycling
- 11 Coalition.
- 12 (x) Two members from the general public.
- 13 Each member may designate an alternate to serve in his stead. A
- 14 member shall notify the chairman in writing of this designation.
- 15 (c) Terms of appointees. -- The terms of all members of the
- 16 committee appointed by the Governor shall be for three years.
- 17 Any member of the committee may be reappointed for additional
- 18 terms. An individual appointed to fill a vacancy shall serve for
- 19 the unexpired term and shall be eligible for reappointment.
- 20 (d) Officers.--The members of the committee shall annually
- 21 elect a chairman, a vice chairman and a secretary from among the
- 22 public members of the committee.
- (e) Meetings and expenses.--
- 24 (1) The committee shall meet at least four times every
- 25 12 months, but may hold additional meetings as are called by
- the chairman or by petition of at least five members of the
- 27 committee.
- 28 (2) A public member, including a designee, who misses
- three consecutive meetings without good cause acceptable to
- 30 the chairman shall be replaced by the chairman, who shall

- 1 have the power to make a temporary appointment pending
- 2 approval or replacement by the Governor.
- 3 (3) The public members of the committee shall be allowed
- 4 per diem expenses to be set by the committee, but not to
- 5 exceed Internal Revenue Service guidelines. The department
- 6 shall provide appropriate staff support to enable the
- 7 committee to properly carry out its functions.
- 8 (f) Powers and duties.--The powers and duties of the
- 9 committee shall be to advise and comment on all phases of
- 10 cycling and pedestrian program activities being undertaken or
- 11 financially assisted by the department and agencies of State
- 12 government and to propose methods, strategies or technologies
- 13 for improving these program activity services, systems or
- 14 facilities within this Commonwealth. The committee shall
- 15 annually submit reports of its general deliberations and
- 16 conclusions, as well as any specific issue reports completed at
- 17 the committee's discretion, to the Governor, members of the
- 18 General Assembly and the State Transportation Commission.
- 19 Section 8. This act shall take effect in 60 days.
