Amending Title 51 (Military Affairs) of the Pennsylvania

AN ACT

Consolidated Statutes, further providing for educational aid for certain members of the Pennsylvania National Guard; and 3 4 conferring powers and duties on the Adjutant General, the 5 Department of Military Affairs and the Pennsylvania Higher 6 Education Assistance Agency. 7 The General Assembly of the Commonwealth of Pennsylvania 8 finds and declares as follows: 9 (1)The Pennsylvania National Guard must recruit 10 thousands of young Pennsylvanians each year to attain and 11 sustain its required troop strength to meet Federal manning 12 requirements and to provide the Governor with a well-trained 13 and organized military force to respond to emergencies in 14 this Commonwealth. 15 The men and women of the Pennsylvania National Guard face increasing leadership and technical challenges and the 16 percentage of members of the National Guard with post-high 17 school, college and technical education must be increased to 18

- 1 meet these challenges.
- 2 (3) Currently available programs are not adequate to
- 3 meet the financial needs of National Guard personnel who are
- 4 pursuing a higher education or to attract young men and women
- 5 into the National Guard who are high school graduates with
- 6 the desire and ability to pursue their higher education in
- 7 Commonwealth colleges and universities or business, trade and
- 8 technical schools.
- 9 (4) The Pennsylvania National Guard needs a cadre of
- 10 well-educated leaders to lead the Guard now and in the
- 11 future.
- 12 (5) An innovative educational assistance program will
- provide public service educational grants for members of the
- 14 Pennsylvania National Guard and will keep Pennsylvania
- student soldiers in this Commonwealth and benefit
- 16 Pennsylvania communities.
- 17 (6) An educational assistance program will reward those
- 18 young Pennsylvanians who volunteer to serve their nation and
- 19 Commonwealth as part of the Pennsylvania National Guard and
- 20 will make this Commonwealth more competitive with other
- 21 states and regular forces in the educational benefits offered
- 22 to military personnel.
- 23 (7) The Educational Assistance Program is designed to
- 24 provide public service educational grants to members of the
- 25 Pennsylvania National Guard by means of grants administered
- 26 by the Pennsylvania Higher Education Assistance Agency.
- 27 The General Assembly of the Commonwealth of Pennsylvania
- 28 hereby enacts as follows:
- 29 Section 1. Section 3104 of Title 51 of the Pennsylvania
- 30 Consolidated Statutes is amended to read:

- 1 § 3104. [Tuition credit] Part-time student assistance.
- 2 [(a) Eligibility.--A nontechnician member of the
- 3 Pennsylvania National Guard in an enlisted grade, warrant
- 4 officer, WO1 or WO2, or officers in the rank of second
- 5 lieutenant or first lieutenant after completing a minimum
- 6 enlistment period as defined by the guard, who enrolls in a
- 7 Pennsylvania institution of higher learning, with degree
- 8 granting status as approved by the Department of Education,
- 9 shall receive a grant of one-half the cost of the credit, with a
- 10 maximum of \$40 per credit while satisfactorily enrolled, with a
- 11 maximum of six credits per quarter or semester or 12 credits per
- 12 year.]
- 13 (a) Eligibility. -- A member of the Pennsylvania National
- 14 Guard serving as an enlisted member, warrant officer, warrant
- 15 officer 1 or warrant officer 2, or officers in the grade of
- 16 <u>second lieutenant or first lieutenant after completing a minimum</u>
- 17 enlistment period, as defined by the Adjutant General, who
- 18 enrolls in a part-time course of study in a Commonwealth-
- 19 approved institution of higher learning, as defined in section
- 20 3202 (relating to eligibility), shall receive a grant of one-
- 21 half of the cost of the tuition payable to the institution,
- 22 provided that the grant paid on behalf of any student for any
- 23 <u>academic year shall not exceed one-half of the cost of the</u>
- 24 maximum tuition charged by any member institution of the State
- 25 System of Higher Education.
- 26 (b) Payment.--Grants shall be paid only upon certification
- 27 each quarter or semester by the Adjutant General that the
- 28 student is a current member in good standing with the
- 29 Pennsylvania National Guard and that his current enlistment
- 30 extends beyond the expiration date of the current quarter or

- 1 semester.
- 2 (c) Administration. -- The Department of Military Affairs
- 3 shall administer the educational grants provided in this section
- 4 from an appropriation made annually to the department for this
- 5 purpose. The department may promulgate rules and regulations on
- 6 the administration and management of this program. The grant
- 7 program shall not exceed the amount of the appropriation. If the
- 8 department determines that the amount appropriated will be
- 9 <u>insufficient to pay the grants in amounts set forth in</u>
- 10 <u>subsection</u> (a), the department shall reduce the amount of the
- 11 grant payments proportionately so that the expenditures do not
- 12 <u>exceed the amounts appropriated.</u>
- 13 Section 2. Title 51 is amended by adding a chapter to read:

- 26 § 3201. Definitions.
- 27 The following words and phrases when used in this chapter
- 28 shall have the meanings given to them in this section unless the
- 29 context clearly indicates otherwise:
- 30 "Agency." The Pennsylvania Higher Education Assistance

- 1 Agency.
- 2 "Approved program of education." A degree or nondegree
- 3 curriculum or course of study to be pursued on a full-time basis
- 4 for a duration of at least two academic years, or its equivalent
- 5 as determined by the Pennsylvania Higher Education Assistance
- 6 Agency, at an approved institution of higher learning.
- 7 "Eligible member." A member of the Pennsylvania National
- 8 Guard who meets the criteria specified in section 3202 (relating
- 9 to eligibility) and who has been awarded a certificate of
- 10 eligibility under section 3203 (relating to certification of
- 11 eligibility).
- 12 "Program." The Educational Assistance Program established in
- 13 this chapter.
- 14 "Qualified resident." An individual who has been a bona fide
- 15 resident of this Commonwealth for a period of at least 12
- 16 consecutive months immediately prior to the time an application
- 17 for a grant is made. The Pennsylvania Higher Education
- 18 Assistance Agency shall make the final decision on whether an
- 19 applicant is a qualified resident.
- 20 "Total education costs." The tuition, room, board, fees and
- 21 cost of books at an approved institution of higher learning in
- 22 amounts approved by the Pennsylvania Higher Education Assistance
- 23 Agency.
- 24 § 3202. Eligibility.
- 25 A Pennsylvania National Guard member is eligible to receive a
- 26 public service educational grant under this chapter for a period
- 27 of not more than four academic years if the member meets all of
- 28 the following eligibility criteria:
- 29 (1) The member is a qualified resident of this
- 30 Commonwealth.

- 1 (2) The member does not possess a baccalaureate degree.
- 2 (3) The member accepts an obligation to serve in the
- 3 Pennsylvania National Guard for a period of six years from
- 4 the date of entry into the program by enlistment,
- 5 reenlistment, extension of enlistment or execution of a
- 6 service commitment.
- 7 (4) The member serves in an enlisted grade or in the
- 8 grade of a warrant officer 1, warrant officer 2, first
- 9 lieutenant or second lieutenant.
- 10 (5) The member is a member in good standing and has been
- 11 a satisfactory participant in Pennsylvania National Guard
- 12 activities for a minimum service period established by the
- 13 Adjutant General.
- 14 (6) The member has enrolled as a full-time student in an
- 15 approved program of education.
- 16 (7) The member is not receiving a Reserve Officer
- 17 Training Corps (ROTC) Scholarship.
- 18 § 3203. Certification of eligibility.
- 19 The department shall certify members of the Pennsylvania
- 20 National Guard as eligible to participate in the program who
- 21 meet the eligibility criteria set forth in section 3202
- 22 (relating to eligibility) and shall provide the agency with a
- 23 certificate of eligibility for an eligible member.
- 24 § 3204. Grants.
- 25 (a) General rule. -- From the funds appropriated for the
- 26 purposes of this chapter, the agency is authorized to provide
- 27 grants to eligible members for the purpose of pursuing approved
- 28 programs of education.
- 29 (b) Promissory notes.--At the receipt of the grant, an
- 30 eligible member shall sign a promissory note to repay the full

- 1 amount of the grant. The promissory note shall be conditional
- 2 upon noncompletion of the service obligation under section
- 3 3207(a) (relating to recoupment of grant payments).
- 4 § 3205. Amount of grants.
- 5 (a) Maximums.--Grants awarded under this chapter to cover
- 6 full-time study shall be determined by the agency without regard
- 7 to financial need and shall not exceed, for each academic year:
- 8 (1) For students receiving grants under the Pell grant
- 9 program or from the agency, the lesser of:
- 10 (i) the tuition of the approved institution of
 11 higher learning in which the eligible member is enrolled;

(ii) the maximum tuition charged by any of the

- 11 higher learning in which the eligible member is enrolled;
- member institutions of the State System of Higher
- 14 Education for a Commonwealth resident pursuing a full-
- time program of study; or
- 16 (iii) the total education cost at an approved
- institution of higher learning in which the eligible
- 18 member is enrolled less the total of all Pell and/or
- 19 agency grants that the member is eligible to receive.
- 20 (2) For students not receiving grants under the Pell
- grant program or from the agency, the lesser of:
- 22 (i) the tuition of the approved institution of
- 23 higher learning in which the eligible member is enrolled;
- 24 or

- 25 (ii) the maximum tuition charged by any of the
- 26 member institutions of the State System of Higher
- 27 Education for a Commonwealth resident pursuing a full-
- time program of study.
- 29 (b) Adjustments.--If the agency, after consultation with the
- 30 Adjutant General, determines that the amount appropriated for

- 1 the program in any year will be insufficient to provide grants
- 2 in the amounts set forth in this section to all eligible
- 3 members, the agency may reduce the maximum amount of the grants
- 4 proportionately to ensure that sums expended do not exceed
- 5 appropriations.
- 6 § 3206. Limitations.
- 7 (a) Time.--No member shall be eligible for grant payments
- 8 under this program for more than four academic years.
- 9 (b) Active duty.--An eligible member must commence
- 10 participation in the program during the term of service as a
- 11 member in good standing of the Pennsylvania National Guard. No
- 12 grant payments shall be made for any academic year commencing
- 13 two or more years after the date of the member's discharge from
- 14 the Pennsylvania National Guard.
- 15 § 3207. Recoupment of grant payments.
- 16 (a) General rule. -- An eligible member who fails to complete
- 17 a six-year service obligation incurred as a result of
- 18 participation in this program or to meet other requirements
- 19 established by the Adjutant General or the agency is liable to
- 20 the Commonwealth for repayment of all grant payments made. The
- 21 Adjutant General shall notify the agency if an eligible member
- 22 fails to complete the service obligation and the promissory note
- 23 under section 3204(b) (relating to grants) shall be payment in
- 24 full upon demand by the agency on a schedule as the agency may
- 25 determine.
- 26 (b) Forgiveness of recoupment.--The Adjutant General may
- 27 advise the agency to forgive recoupment of all or part of an
- 28 eligible member's grant payments if the Adjutant General
- 29 determines that the member's failure to fulfill the six-year
- 30 service obligation was the result of the eligible member's

- 1 death, discharge because of disability incurred in line of duty,
- 2 discharge because of a medical determination that the eligible
- 3 member is medically unfit for duty when the medical condition is
- 4 outside the eligible member's control and is not due to his
- 5 misconduct or discharge or release because of other compelling
- 6 circumstances outside the eligible member's control.
- 7 § 3208. Regulations.
- 8 The Adjutant General and the agency may promulgate
- 9 regulations to carry out the provisions of this chapter.
- 10 § 3209. Administration.
- 11 The agency is authorized to use an appropriate portion of the
- 12 funds appropriated for the program to pay the costs of the
- 13 administration of this chapter.
- 14 Section 3. This act shall take effect July 1, 1995, or
- 15 immediately, whichever is later.
