AN ACT

- Amending the act of November 22, 1978 (P.L.1166, No.274), 2 entitled "An act establishing the Pennsylvania Commission on 3 Crime and Delinquency, providing for its powers and duties 4 establishing several advisory committees within the 5 commission and providing for their powers and duties, " authorizing a crime prevention program; providing for technical and financial assistance to law enforcement 8 agencies; and making an appropriation. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. The preamble of the act of November 22, 1978 (P.L.1166, No.274), referred to as the Pennsylvania Commission 12 13 on Crime and Delinquency Law, is amended to read: The General Assembly finds and declares that: 14
- --
- 15 (a) crime and delinquency are essentially State and local
- 16 problems;
- 17 (b) crime and delinquency are complex social phenomena
- 18 requiring the attention and efforts of the criminal justice
- 19 system, State and local governments, and private citizens alike;

- 1 (c) the establishment of appropriate goals, objectives and
- 2 standards for the reduction of crime and delinquency and for the
- 3 administration of justice must be a priority concern;
- 4 (d) the functions of the criminal justice system must be
- 5 coordinated more efficiently and effectively;
- 6 (e) the full and effective use of resources affecting State
- 7 and local criminal justice systems requires the complete
- 8 cooperation of State and local government agencies; [and]
- 9 (f) training, research, evaluation, technical assistance and
- 10 public education activities must be encouraged and focused on
- 11 the improvement of the criminal justice system and the
- 12 generation of new methods for the prevention and reduction of
- 13 crime and delinquency[.]<u>;</u>
- 14 (q) the efforts of law enforcement to combat the incidence
- 15 of crime are enhanced substantially when communities take steps
- 16 to reduce the opportunity for crime through effective police
- 17 <u>leadership in crime prevention planning, public education and</u>
- 18 the responsible organization of community resources; and
- 19 (h) it is in the public interest for the Commonwealth to
- 20 establish a central crime prevention program to provide
- 21 <u>leadership and technical and financial assistance to law</u>
- 22 enforcement agencies to develop and maintain community crime
- 23 prevention initiatives.
- Section 2. Section 1 of the act, amended April 30, 1986
- 25 (P.L.125, No.38), is amended to read:
- 26 Section 1. Definitions.
- 27 The following words and phrases when used in this act shall
- 28 have, unless the context clearly indicates otherwise, the
- 29 meanings given to them in this section:
- 30 "Citizens advisory committee." A group of not less than ten

- 1 private citizens from a municipality whose duty shall be to
- 2 <u>assist the servicing law enforcement agency in developing its</u>
- 3 <u>crime prevention program.</u>
- 4 "Commission." The Pennsylvania Commission on Crime and
- 5 Delinguency.
- 6 <u>"Crime prevention."</u> The elimination or reduction of the
- 7 opportunity for criminal activity through the initiatives of
- 8 agencies of State and local government undertaken in cooperation
- 9 with members of the public.
- 10 "Governing body." The council in cities, boroughs and
- 11 <u>incorporated towns</u>, the board of commissioners in townships of
- 12 the first class, the board of supervisors in townships of the
- 13 second class, the legislative policymaking body in counties and
- 14 home rule municipalities or other general purpose units of
- 15 government which may be created by the General Assembly,
- 16 <u>including councils of government organized pursuant to the act</u>
- 17 of July 12, 1972 (P.L.762, No.180), referred to as the
- 18 Intergovernmental Cooperation Law.
- 19 "Local law enforcement agency." A law enforcement agency
- 20 <u>created by a municipality pursuant to statute.</u>
- 21 "Municipality." Every city, borough, county, incorporated
- 22 town, township and home rule municipality or other general
- 23 purpose unit of government which may be created by the General
- 24 Assembly, including councils of government organized pursuant to
- 25 the act of July 12, 1972 (P.L.762, No.180), referred to as the
- 26 Intergovernmental Cooperation Law.
- 27 "Private citizen." An individual who is not an elected or
- 28 appointed official in a branch of government of the United
- 29 States, the Commonwealth or a political subdivision.
- 30 "State law enforcement agency." The Pennsylvania State

- 1 Police.
- 2 Section 3. The act is amended by adding sections to read:
- 3 <u>Section 3.1. Duties of commission relative to crime prevention.</u>
- 4 The commission shall have the power and its duty shall be:
- 5 (1) To develop Statewide strategies to implement crime
- 6 prevention programs at the State and local level.
- 7 (2) To review State agency plans to ensure the
- 8 <u>coordination of the delivery of crime prevention services.</u>
- 9 (3) To develop, coordinate and administer crime
- 10 prevention-related training programs for State and local law
- 11 enforcement agency personnel on current issues and techniques
- in the field of crime prevention.
- 13 (4) To provide leadership and on-site technical
- 14 <u>assistance services to State agencies and local law</u>
- 15 <u>enforcement agencies in developing and implementing crime</u>
- 16 <u>prevention programs</u>.
- 17 (5) To assure the design, development and availability
- of crime prevention materials.
- 19 (6) To promote the involvement of community
- 20 <u>organizations in the development and implementation of crime</u>
- 21 <u>prevention programs</u>.
- 22 (7) To submit, on a biennial basis, a report to the
- 23 Governor and the General Assembly concerning the status of
- 24 <u>crime prevention programs throughout the State.</u>
- 25 <u>Section 3.2. Crime prevention financial assistance.</u>
- 26 (a) Applications. -- The commission shall solicit and receive
- 27 applications from local law enforcement agencies for financial
- 28 <u>assistance to implement crime prevention programs and allocate</u>
- 29 State funds to applicants in accordance with the provisions of
- 30 applicable statutes and regulations.

- 1 (b) Pennsylvania State Police applications. -- The
- 2 Pennsylvania State Police may apply for and receive financial
- 3 <u>assistance under the provisions of this section for crime</u>
- 4 prevention programs implemented in those areas of the
- 5 <u>Commonwealth for which the Pennsylvania State Police serves as</u>
- 6 the principal law enforcement agency.
- 7 (c) Assurances and plan. -- An application for financial
- 8 assistance under the provisions of this section shall contain
- 9 <u>assurances that the applicant will submit semiannual reports on</u>
- 10 the progress of its crime prevention activities and will comply
- 11 with those requirements that the commission may reasonably
- 12 <u>adopt. The application shall also include a crime prevention</u>
- 13 services plan containing, as a minimum, all of the following
- 14 elements:
- 15 (1) A project plan which includes a goal statement,
- 16 specific project objectives, a project budget statement, a
- 17 <u>description of the quantity and type of resource materials</u>
- needed and a project evaluation methodology.
- 19 (2) A description of the types of crime prevention
- 20 <u>activities proposed to be conducted by the applicant and a</u>
- 21 <u>specification of the nature and extent of the direct</u>
- 22 participation of community organizations in the proposed
- 23 activities.
- 24 (3) A description of the nature and extent of
- 25 <u>participation by persons representing the business community</u>
- 26 in the proposed activities and a specification of those
- 27 proposed activities which are intended to have an impact upon
- 28 <u>crimes affecting the local business community.</u>
- 29 <u>(4) A specific identification of the nature and types of</u>
- 30 crimes upon which the proposed activities are intended to

- 1 <u>impact and the level of impact the activities are projected</u>
- 2 to achieve.
- 3 (5) A description of the geographic area within which
- 4 <u>the proposed activities will be primarily conducted.</u>
- 5 (d) Approval of application. -- The commission may not approve
- 6 an application for financial assistance under this section
- 7 unless:
- 8 (1) the application has been duly authorized and
- 9 approved in writing by the governing body of the municipality
- served by a local law enforcement agency applicant or by the
- 11 <u>Commissioner of the Pennsylvania State Police in the case of</u>
- a State law enforcement agency application; and
- 13 (2) the application has been reviewed and commented upon
- by an advisory committee composed of not less than ten
- residents of the municipality to be served under the
- 16 application. The advisory committee referred to in this
- 17 paragraph shall be appointed by the governing body of the
- 18 municipality served by a local law enforcement agency
- 19 applicant or by the Commanding Officer of the Pennsylvania
- 20 <u>State Police installation for the jurisdiction to be served</u>
- 21 in the case of a State law enforcement agency application and
- 22 shall be fairly representative of the interests of residents
- and business in the municipality.
- 24 (e) Allocation of funds. -- The commission shall make
- 25 <u>available not less than 80% of the State funds appropriated</u>
- 26 annually for the administration of this section for financial
- 27 assistance to State and local enforcement agencies for the
- 28 support of municipal, county or regional crime prevention
- 29 projects. The funds shall be used to pay 50% of an individual
- 30 project's cost, provided the projects are operated under the

- 1 guidance of a law enforcement officer or other governmental
- 2 employee, who has successfully completed those courses of
- 3 <u>instruction required by the commission. No one project would be</u>
- 4 <u>eligible to receive more than three years of funding. The</u>
- 5 remaining 50% of a project's funding shall come from local
- 6 resources, except that the commission may lower this requirement
- 7 where the crime prevention program is part of a local economic
- 8 <u>development initiative and a lower match is deemed necessary for</u>
- 9 project implementation. Individual counties or groups of
- 10 counties acting in concert may apply for funding to support
- 11 <u>countywide or regional crime prevention plans.</u>
- 12 (f) Commission use of funds. -- The commission may retain the
- 13 balance of the State funds appropriated annually for the
- 14 operation of a centralized crime prevention program and
- 15 <u>administration of the financial assistance requirements</u>
- 16 <u>contained in this section.</u>
- 17 (q) Grant administration. -- Grants of financial assistance
- 18 made under this section shall be subject to the provisions of
- 19 section 3(4) and (5).
- 20 Section 4. The sum of \$250,000, or as much thereof as may be
- 21 necessary, is hereby specifically appropriated to the
- 22 Pennsylvania Commission on Crime and Delinquency for the fiscal
- 23 year July 1, 1995, to June 30, 1996, to carry out the purposes
- 24 of this act.
- 25 Section 5. This act shall take effect July 1, 1995.
