12	The General Assembly of the Commonwealth of Pennsylvania	
13	hereby enacts as follows:	
14	Section 1. The sum of \$24,406,000, or as much thereof as may	<
15	be necessary, is hereby appropriated from the Public School	
16	Employees' Retirement Fund to the Public School Employees'

17	Retirement Board for the payment of all salaries, wages and

4 SECTION 1. THE SUM OF \$15,850,000, OR AS MUCH THEREOF AS MAY <-----BE NECESSARY, IS HEREBY APPROPRIATED FROM THE STATE EMPLOYEES' 5 RETIREMENT FUND TO THE STATE EMPLOYEES' RETIREMENT BOARD FOR THE 6 7 PAYMENT OF ALL SALARIES, WAGES AND OTHER COMPENSATION AND TRAVEL 8 EXPENSES OF THE EMPLOYEES AND MEMBERS OF THE STATE EMPLOYEES' 9 RETIREMENT BOARD, FOR CONTRACTUAL SERVICES AND OTHER EXPENSES 10 NECESSARY FOR THE PROPER CONDUCT OF THE DUTIES, FUNCTIONS AND 11 ACTIVITIES OF THE BOARD FOR THE FISCAL YEAR BEGINNING JULY 1, 1995, AND FOR THE PAYMENT OF BILLS INCURRED AND REMAINING UNPAID 12 13 AT THE CLOSE OF THE FISCAL YEAR ENDING JUNE 30, 1995. Section 2. This act shall take effect July 1, 1995, or 14 15 immediately, whichever is later.
