## AN ACT

- 1 Making an appropriation to the Pennsylvania College of 2 Optometry, Philadelphia.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The sum of \$1,548,000 is hereby appropriated to
- 6 the Pennsylvania College of Optometry, Philadelphia, for the
- 7 fiscal year July 1, 1995, to June 30, 1996, for instruction.
- 8 Section 2. Payments to the Pennsylvania College of Optometry
- 9 on account of the appropriation provided in section 1 shall be
- 10 made quarterly by the Secretary of Education on the basis of
- 11 costs during the fiscal year. The secretary shall not release
- 12 more than the first quarterly payment until such time as the
- 13 Trustees of the Pennsylvania College of Optometry agree in
- 14 writing to include a minimum of five members appointed by the
- 15 Governor and the General Assembly. The Governor, the President
- 16 pro tempore of the Senate, the Minority Leader of the Senate,
- 17 the Speaker of the House of Representatives and the Minority

- 1 Leader of the House of Representatives may each, upon receipt of
- 2 the written agreement from the trustees, appoint a nonelected
- 3 official to serve as a member of the board and the terms of
- 4 office shall be coterminous with that of their appointing
- 5 authority.
- 6 Section 3. The Pennsylvania College of Optometry shall
- 7 provide full, complete and accurate information as may be
- 8 required by the Department of Education or the chairman or the
- 9 minority chairman of the Appropriations Committee of the Senate
- 10 or the chairman or the minority chairman of the Appropriations
- 11 Committee of the House of Representatives.
- 12 Section 4. The Pennsylvania College of Optometry shall
- 13 report its revenues and expenditures and present its financial
- 14 statements in accordance with generally accepted accounting
- 15 principles and procedures for educational institutions as set
- 16 forth in the "Higher Education Finance Manual (1975)" and the
- 17 "Commonwealth of Pennsylvania Budget Instructions for the State
- 18 System of Higher Education, State-Related Universities and Non-
- 19 State-Related Colleges and Universities."
- 20 Section 5. The trustees of the Pennsylvania College of
- 21 Optometry shall report on forms provided by the Department of
- 22 Education to both the chairman and minority chairman of the
- 23 Appropriations Committee of the Senate and the chairman and
- 24 minority chairman of the Appropriations Committee of the House
- 25 of Representatives by September 30, 1996, on how State-
- 26 appropriated funds were expended for fiscal year 1995-1996 to
- 27 reduce the costs to Pennsylvania resident students or to provide
- 28 services to Pennsylvania residents.
- 29 Section 6. This act shall take effect July 1, 1995, or
- 30 immediately, whichever is later.
