AN ACT

1 2	Making appropriations to the Trustees of the University of Pennsylvania.
3	The General Assembly of the Commonwealth of Pennsylvania
4	hereby enacts as follows:
5	Section 1. The following sums, or as much thereof as may be
6	necessary, are hereby appropriated to the Trustees of the
7	University of Pennsylvania for the fiscal year July 1, 1995, to
8	June 30, 1996, for the purposes and in the amounts as shown:
9	(1) For instruction, excluding Veterinary
10	Medicine programs and Doctor of Medicine \$9,489,000
11	(2) For dental clinics
12	(3) For instruction in the Doctor of Medicine
13	program
14	(4) For instruction in Veterinary Medicine
15	programs only 10,456,000
16	(5) For the New Bolton Animal Center 7,154,000
17	(6) For the Center for Animal Health and

1,201,000 1 Productivity..... 2 (7) For food and animal clinics and services.. 1,968,000 3 Section 2. Payments to the University of Pennsylvania on 4 account of the appropriations for the items provided in section 5 1 shall be made quarterly by the Secretary of Education on the basis of costs during the fiscal year. The secretary shall not 6 release more than the first quarterly payment until such time as 7 the trustees of the University of Pennsylvania agree in writing 8 to include a minimum of four members appointed by the General 9 10 Assembly. The President pro tempore of the Senate, the Minority 11 Leader of the Senate, the Speaker of the House of Representatives and the Minority Leader of the House of 12 13 Representatives may each, upon receipt of the written agreement 14 from the trustees, appoint a nonelected official to serve as a 15 member of the board and the terms of office shall be coterminous 16 with that of their appointing authority.

17 Section 3. The University of Pennsylvania shall provide 18 full, complete and accurate information as may be required by 19 the Department of Education or the chairman or the minority 20 chairman of the Appropriations Committee of the Senate or the 21 chairman or the minority chairman of the Appropriations Committee of the House of Representatives. 22

23 Section 4. The University of Pennsylvania shall report its revenues and expenditures and present its financial statements 24 25 in accordance with generally accepted accounting principles and 26 procedures for educational institutions as set forth in the "Higher Education Finance Manual (1975)" and the "Commonwealth 27 28 of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-29 30 Related Colleges and Universities." 19950H1815B2176

1 Section 5. The trustees of the University of Pennsylvania 2 shall report on forms provided by the Department of Education to 3 both the chairman and minority chairman of the Appropriations Committee of the Senate and the chairman and minority chairman 4 of the Appropriations Committee of the House of Representatives 5 by September 30, 1996, on how State-appropriated funds were 6 expended for fiscal year 1995-1996 to reduce the costs to 7 8 Pennsylvania resident students or to provide services to Pennsylvania residents. 9

Section 6. This act shall take effect July 1, 1995, or immediately, whichever is later.
